145. Crash Description/Narrative

On scene accident investigation revealed that both vehicle were traveling eastbound on Route 70 in the area of Olden St. Vehicle 1 was attempting to merge into the center lane because the right lane was ending. Vehicle 1 then side swiped vehicle 2 causing damage to the right side of vehicle 2. Vehicle 1 had damage to the left rear quarter panel just above the tire. No injuries were reported on scene and the vehicles were parked in the shoulder of the roadway upon my arrival.

Driver of vehicle 1 stated that she was traveling eastbound on Route 70 just past Olden St when she was attempting to merge left because the right lane was ending. While merging, vehicle 1 crossed over the lane markings and into the center lane. Driver of vehicle 1 then stated that she did not see vehicle 2 and side swiped it.

Driver of vehicle 2 stated that he was travelling eastbound on Route 70 in the center lane just past Olden St. At that time vehicle 1 entered vehicle 2's lane of travel and side swiped vehicle 2.

I find the driver of vehicle 1 at fault for unsafely crossing into the lane of travel of vehicle 2.

Driver of vehicle 1 was issued summons E19-3191 for 39:4-88b.

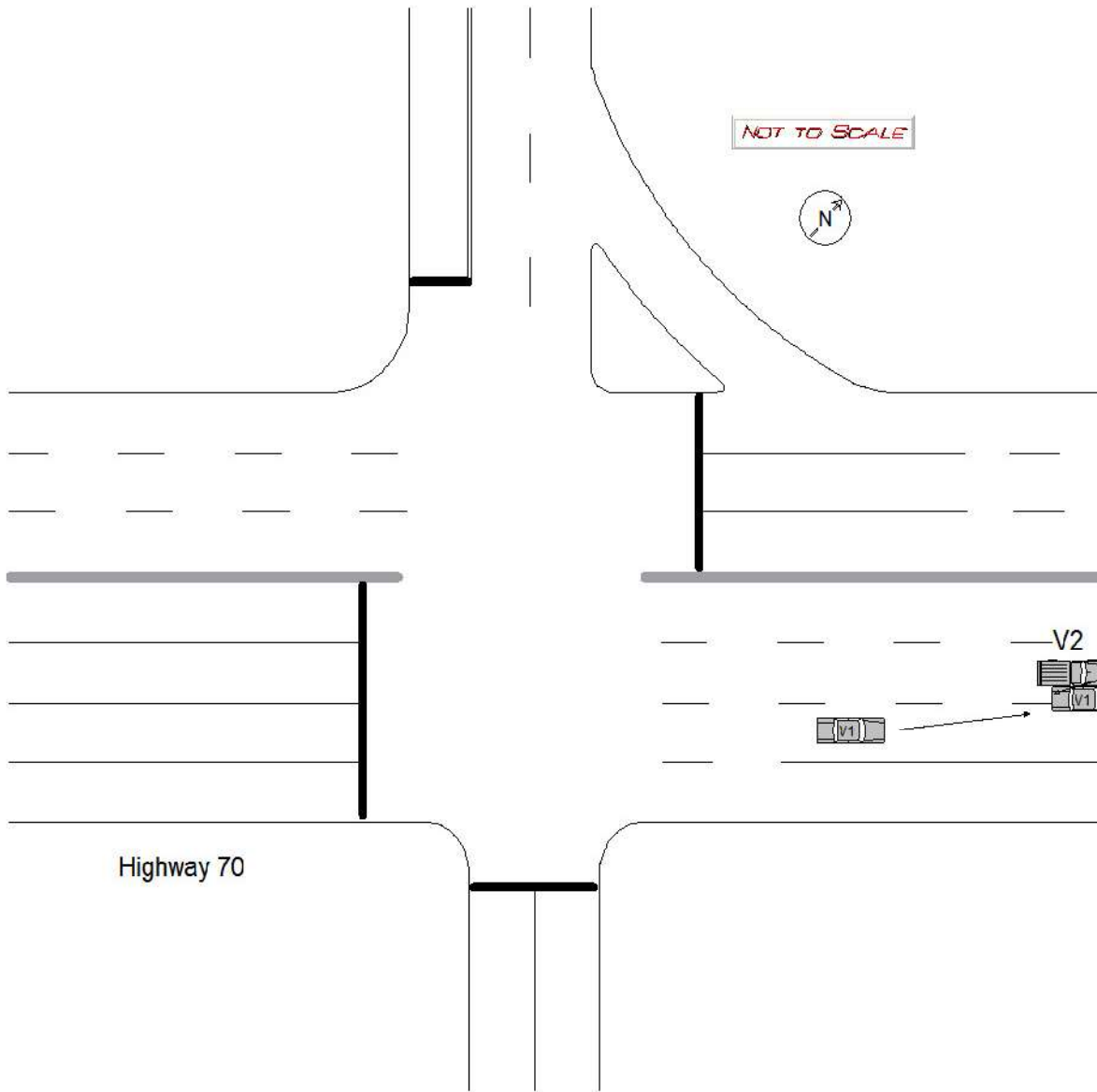
