145. Crash Description/Narrative

Vehicle 2 was backing out of a parking space in the parking lot of Walmart (1872 RT 88). and had completely backed out of its space, when Vehicle 1 began backing out of an adjacent parking space in the same lot and backed into Vehicle 2.

Driver 2 stated he had finished backing out of his parking space and was slowing to a stop when his vehicle was backed into by Vehicle 1.

Driver 1 stated she checked the area behind her prior to backing out of her parking space, but did not see Vehicle 2 due to a blind spot. Driver 1 had a complaint of neck pain as a result of the crash and refused any medical attention at the time of this report.

My on scene investigation found Vehicle 1 to be a fault for the crash, both vehicles were driven from the scene and no motor vehicle summonses were issued.

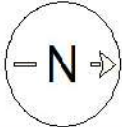

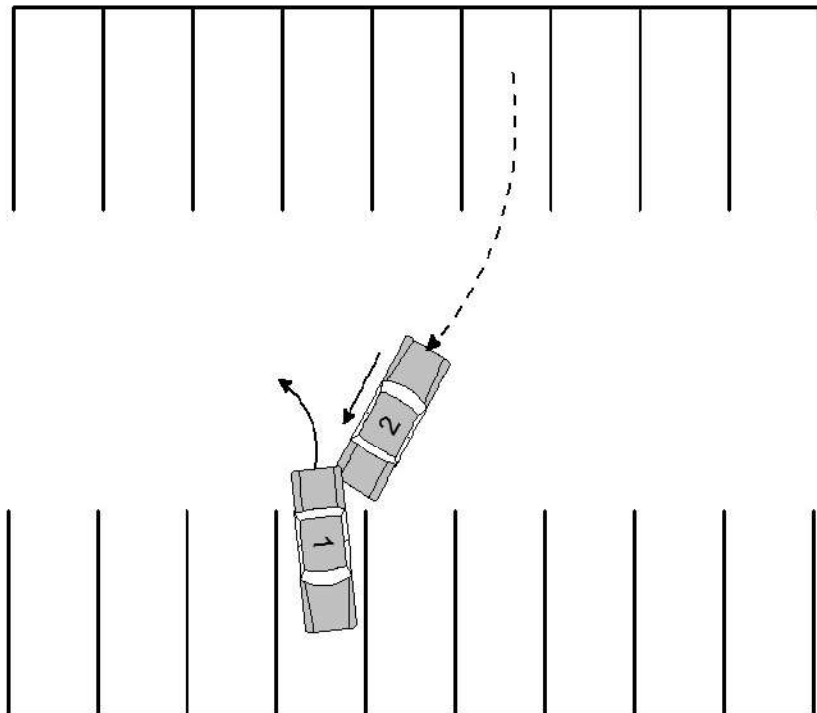
144 Crash Diagram (NOT TO SCALE)
