145. Crash Description/Narrative

On 05/14/2019 at approximately 1655 hours a two car motor vehicle crash occurred on Route 88 in the area of Laurel Square. Vehicle #1 was traveling west bound on Route 88. Vehicle #2 was traveling east bound on Route 88. Vehicle #1 made a left hand turn in front of Vehicle #2, subsequently causing the vehicles to collide.

Driver of Vehicle #1 stated he thought he had enough time to turn and when he accelerated his vehicles spun. He further stated that he guessed that the Driver of Vehicle #2 did not see him turning.

Driver of Vehicle #2 stated Vehicle #1 turned directly in front of his path of travel and tried to stop but did not have time.

A witness on scene stated he observed Vehicle #1 turn in front of Vehicle #2 and heard his tires spin out. He advised Vehicle #1 had no chance to stop his vehicle to avoid collision.

Vehicle #2 was disabled as a result of the crash and removed from the scene by D&L Towing.

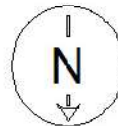
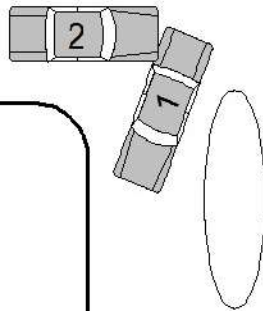
