145. Crash Description/Narrative

Vehicle 01 was traveling west on Route 70 in the left lane near the intersection of Olden Street. As vehicle 01 approached the intersection of Route 70 and Olden Street Vehicle 01 stuck the sand filled crash barrels at the end of the center concrete barrier causing vehicle 01 to roll on to it's roof and resting near the traffic light on the west corner of Olden Street and Route 70.

The driver of vehicle 01 stated she was coming home from work and was tired. Vehicle 01 was traveling west in the left lane of Route 70 near the intersection of Olden Street. The driver of vehicle 01 stated she must have fallen asleep while driving and she woke up as her vehicle struck the crash barrels which ultimately caused the vehicle roll over onto it's roof.

The driver of vehicle 01 had a complaint of pain in the area of her chest and was transported to Ocean Medical Center by Brick Police EMS. I issued the driver a summons #E024559 for careless driving (39:4-97).

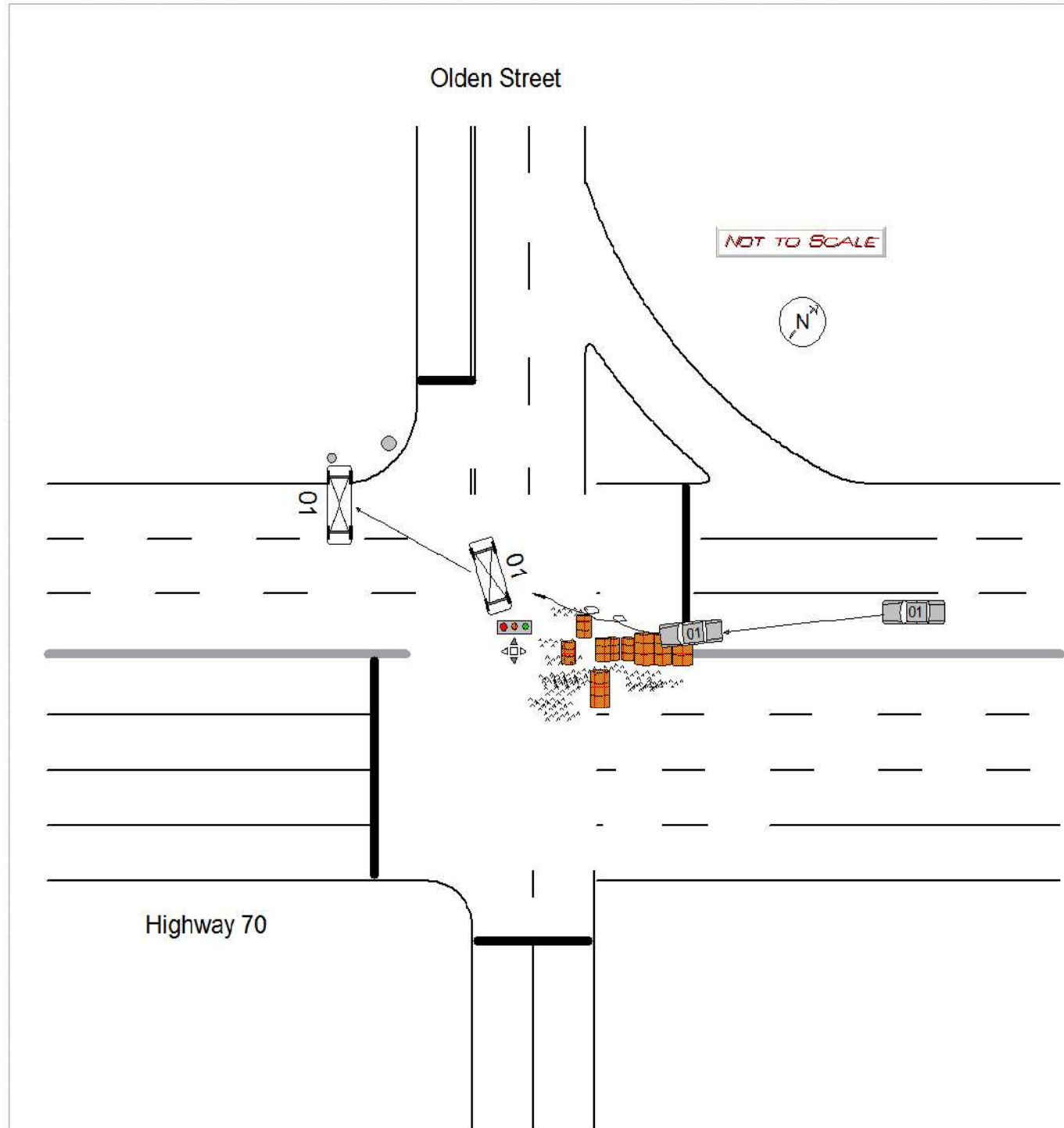
