145. Crash Description/Narrative

Investigation revealed driver of vehicle #1 ran off the road to the right and hit the curb with the right tire.

The vehicle went on top of the curb and caused damage to both front wheels along with the front axle. Driver of vehicle #1 then drove off of the curb and back onto the street with a disabled vehicle.

Driver of vehicle #1 stated he was not "Exactly sure" how and why he struck the curb but only that he knew that he did. He stated he was tired from being in the hospital all night and wanted to go home to sleep.

Driver of vehicle #1 refused medical attention on scene.
