145. Crash Description/Narrative

Vehicle 1 was traveling West while backing out of the driveway of 122 Sullivan Rd. Vehicle 2 was traveling North on Sullivan Rd. Vehicle 1 struck Vehicle 2 in the passenger side middle door with its left upper rear taillight while backing out of the driveway. Both vehicles received minor damage.

Driver 1 advised that while backing out of the driveway of 122 Sullivan Rd. he saw Vehicle 2 in his back up camera. Driver 1 advised he came to a stop and then felt the collision. Driver 2 advised that while he was traveling North on Sullivan Rd. he saw Vehicle 1 come to a stop but advised as he passed, Vehicle 1 "jumped backwards" into Vehicle 2.

Based on my observations and statements made by both drivers, I determine Driver 1 at fault for improper backing.

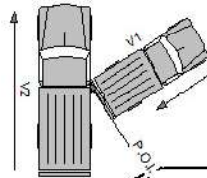
