145. Crash Description/Narrative

Vehicle #3 was traveling westbound on Route 88 and was stopped in traffic directly in front of vehicle #2.

Vehicle #2 was traveling westbound on Route 88 and was stopped in traffic directly behind vehicle #3. Vehicle #1 was traveling westbound on Route 88 going straight ahead. Vehicle #1 was traveling directly behind vehicle #2.

Driver #3 stated she was stopped in traffic when all of a sudden she felt the impact of vehicle #2 collide into the rear of her vehicle. Driver #3 was unsure of how the collision happen because vehicle #2 was already stopped directly behind her vehicle.

Driver #3 complained of neck and back pain and was transported to Ocean Medical Center for further evaluation. The Passenger in vehicle #3 had a minor cut on her lip that was bleeding, but refused medical attention.

Vehicle #3 had minor damage to the rear bumper and was removed from the scene by a relative.

Driver #2 stated she was stopped in traffic directly behind vehicle #3 when she observed vehicle #1 through her rear view mirror not stopping or slowing down. Driver #2 said she doesn't believe vehicle #1 even applied his brakes before colliding into the rear of her vehicle causing disabling damage to the rear bumper, fender, and

windows. Driver #2 said the force of the impact pushed her vehicle into the rear bumper of vehicle #3.

Driver #2 complained of head/neck pain and was transported to Ocean Medical Center.

The Passenger of vehicle #2 complained of leg pain and was also transported to OMC.

Driver #1 stated he was traveling behind vehicle #2 and when the traffic stopped short vehicle #1 was unable to stop in time causing vehicle #1 to collide into vehicle #2.

On scene investigation revealed driver #1 to be at fault due to driver inattention which caused vehicle #2 to collide into vehicle #3.

Driver #1 was issued a summons for careless driving (39:4-97)

Driver #1 was not injured.

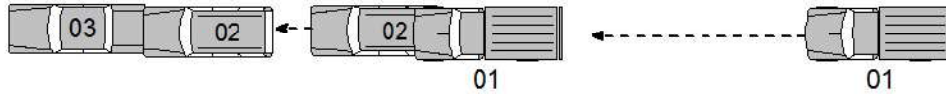
