145. Crash Description/Narrative

A motor vehicle crash occurred on Route 88 at the intersection with Midstreams Road.

Driver of Vehicle #1 advised he was stopped at the red light on Midstreams Road and Route 88. Driver #1 advised he looked up and thought the light was green and began to move. Driver #1 advised he did not realize his traffic light was red and while traveling through the intersection, was struck by Vehicle #2 traveling east on Route 88.

Driver of Vehicle #2 advised he was traveling east on Route 88 towards the intersection of Midstreams Road.

Driver #2 advised Vehicle #1 drove through the red light and struck his vehicle.

The passenger of Vehicle #2 advised she had complaint of pain in her right elbow. The passenger refused any medical services.

Vehicle #1 failed to observe the traffic signal and struck Vehicle #2, traveling straight on Route 88. There was moderate damage to the front driver side of Vehicle #1 and moderate damage to the rear passenger side of Vehicle

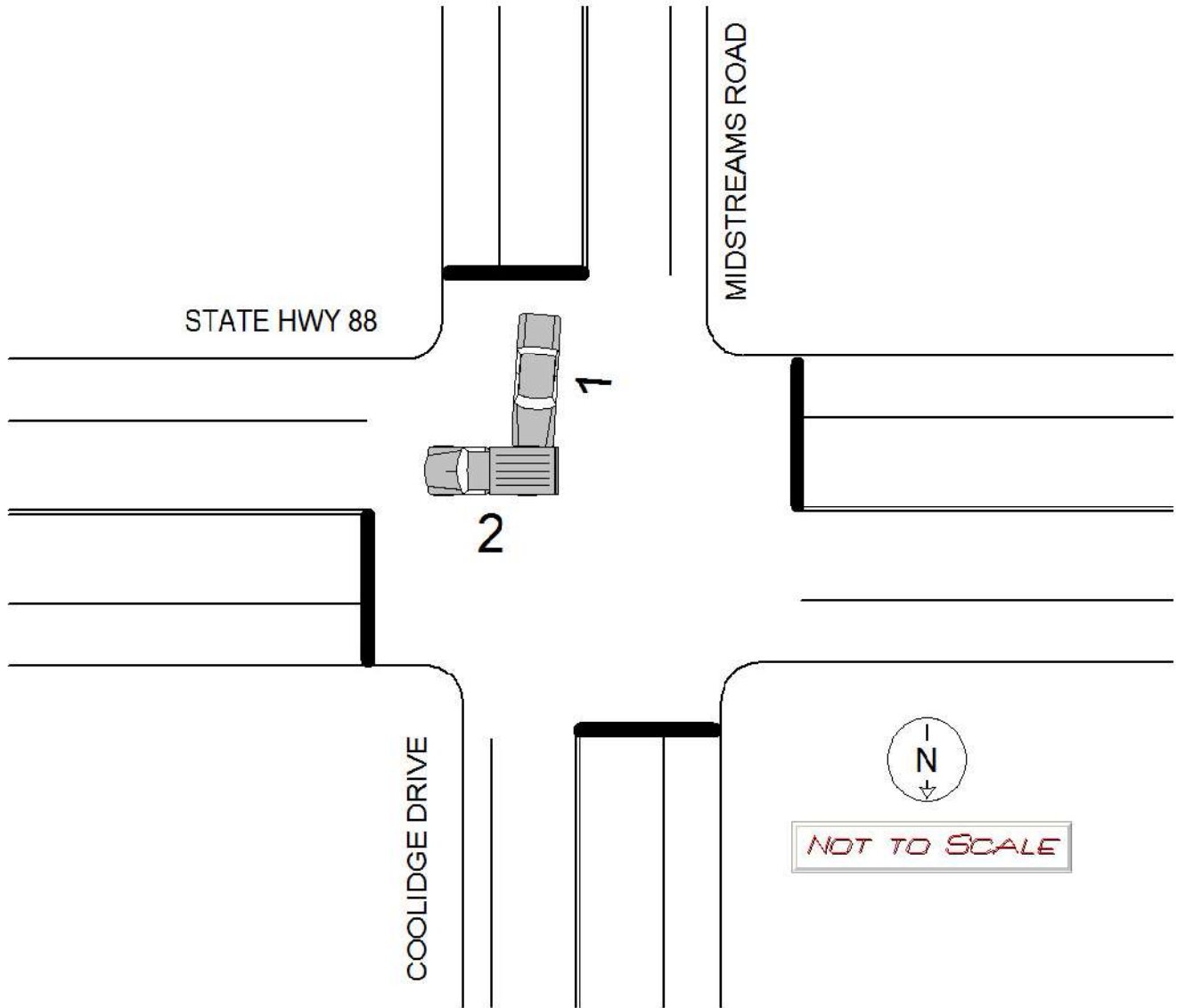
