145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 was parked in the parking lot at Walmart located at 1872 Route 88. Vehicle 1 backed out of the parking space and hit vehicle 2 on the passenger side rear upper panel, which caused a minor dent. Vehicle 1 left the scene.

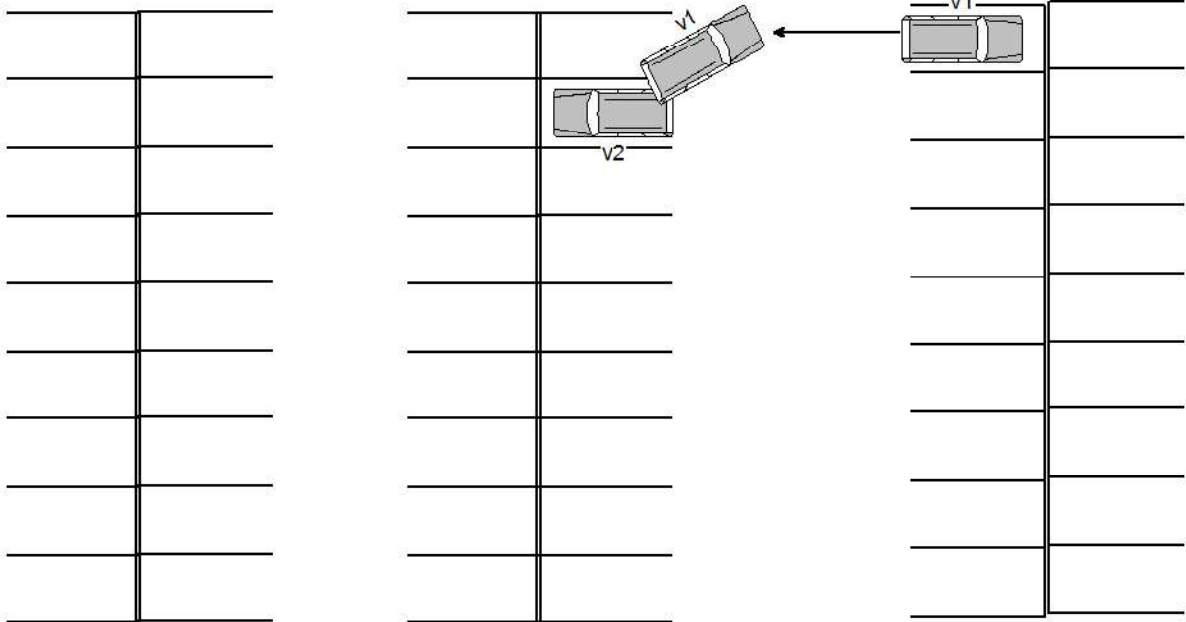
