145. Crash Description/Narrative

Vehicle #1 was attempting a left turn from Jack Martin Blvd into the Kinetic Medical Park (497 Jack Martin Blvd). Vehicle #2 was traveling south on Jack Martin Blvd. about to pass the entrance to the Kinetic Medical Park. Vehicle #1 started to make it's turn in front of oncoming Vehicle #2 causing the crash.

The driver of Vehicle #1 stated that she saw Vehicle #2 coming but believed she had time to make the turn. In doing so, she crashed into it. She stated that Vehicle #2 must have been speeding.

The driver of Vehicle #2 stated that he was traveling on Jack Martin Blvd when he saw Vehicle #1 start to make it's left turn but then stop. He explained that he believed that the driver of Vehicle #1 saw him coming and decided to allow him to pass before making the left turn. The driver of Vehicle #2 stated that as he got closer, Vehicle #1 started to turn in front of his vehicle and that he attempted to evade it but could not.

No injuries were initially reported. I had asked the driver of Vehicle #1 if she wished first aid as her front air bags activated but she denied it and wanted to call her husband. Her husband later responded and took his wife to her doctors appointment in the medical park. Sometime after, the driver of Vehicle #1 came back out to the scene with her doctor. The doctor requested that she be taken to the hospital due to bruising. He was alright with the husband taking her over to the Ocean Medical Center, which he later did.

The driver of Vehicle #2 also initially denied first aid but later stated that his forearm started to hurt.

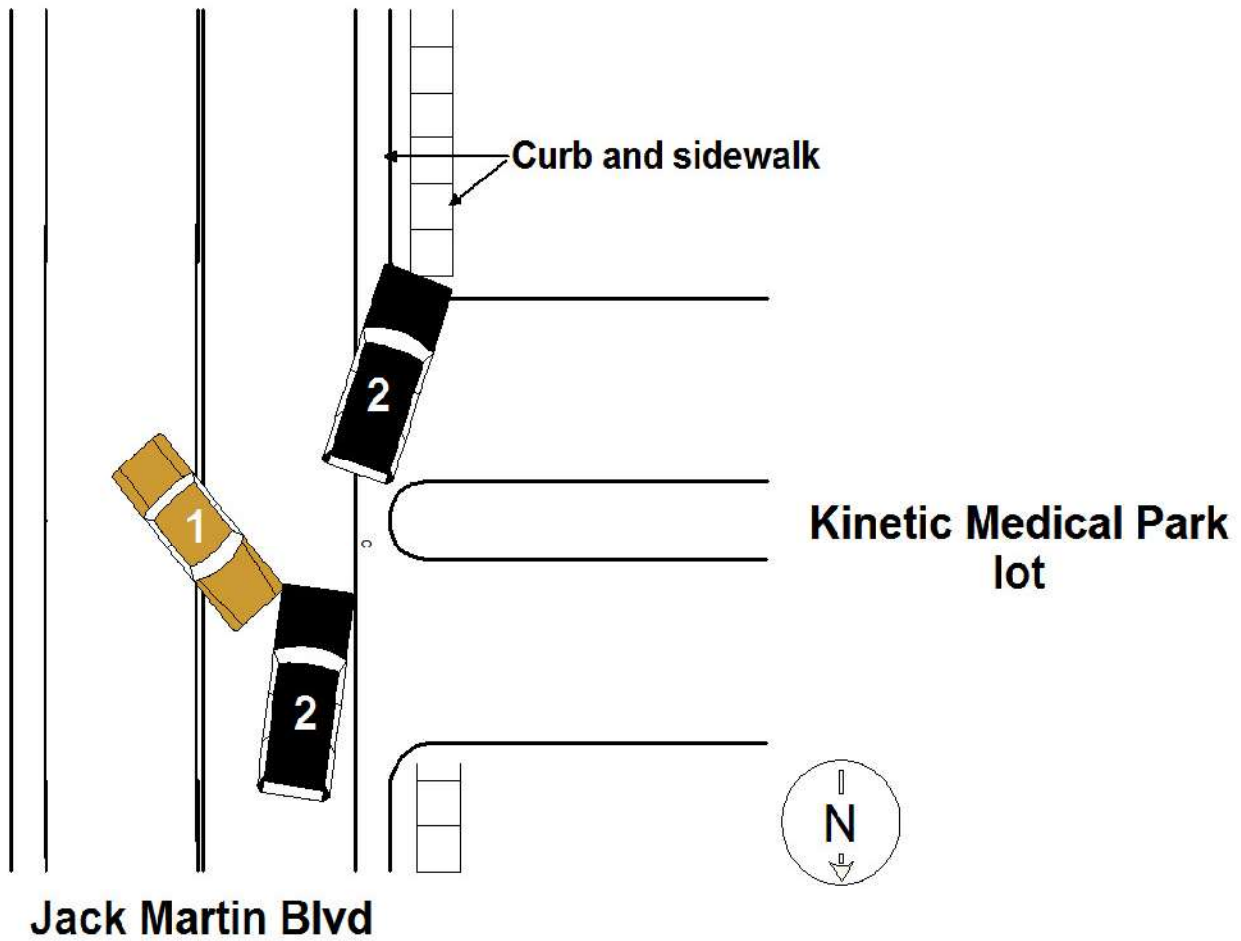
