145. Crash Description/Narrative

Vehicle 2 was traveling in the Wendy's parking lot (101 Jack Martin Blvd) when Vehicle 1 backed into her. Driver 1 stated he was backing up and did not see Vehicle 2. Driver 1 stated his tailgate of his pickup truck was down which struck Vehicle 2. On scene I observed damage to the passenger side of Vehicle 2 (dent and/or crease). Investigation reveals that Driver 1 was inattentive while he was backing out of a parking stall which caused this crash.

There were no reported injuries at the time of this report. Driver 1 was issued a summons for careless driving (T-161498: 39:4-97).

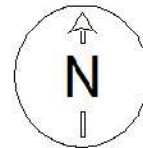
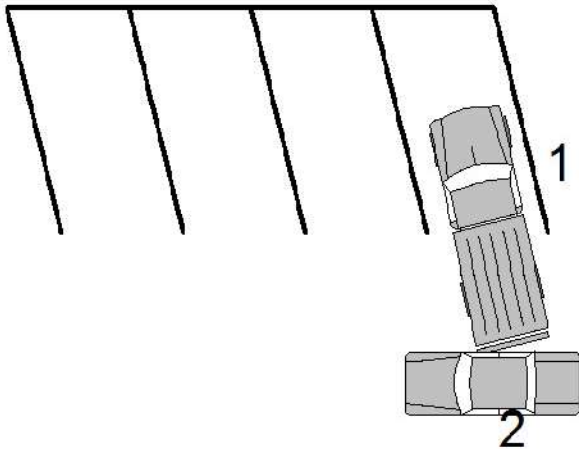
