145. Crash Description/Narrative

Two car crash occurred in the parking lot of 186 Jack Martin Blvd. in front of Building E. My body worn camera was on during this investigation.

Driver of vehicle #1, Michaelle Bauter, advised she was backing out of a marked parking space and was unable to see past a pickup truck parked next to her. Bauter advised she began backing and was unaware of vehicle #2 in the aisle and struck vehicle #2 in the front right with the right rear of her vehicle. Bauter admitted fault.

Driver of vehicle #2, Virginia Decker, advised she was traveling slowly in the parking lot aisle and came to a stop to drop her passenger, Karen Liebhauser, off at a doctor's appointment. Decker stated she saw vehicle #1 begin backing up towards her. Decker advised she pressed her horn several times and also began backing up in order to try to get out of the way. Decker stated vehicle #1 struck her vehicle in the right front.

No injuries were reported.

Driver of vehicle #1 is at fault for backing unsafely and driver inattention.

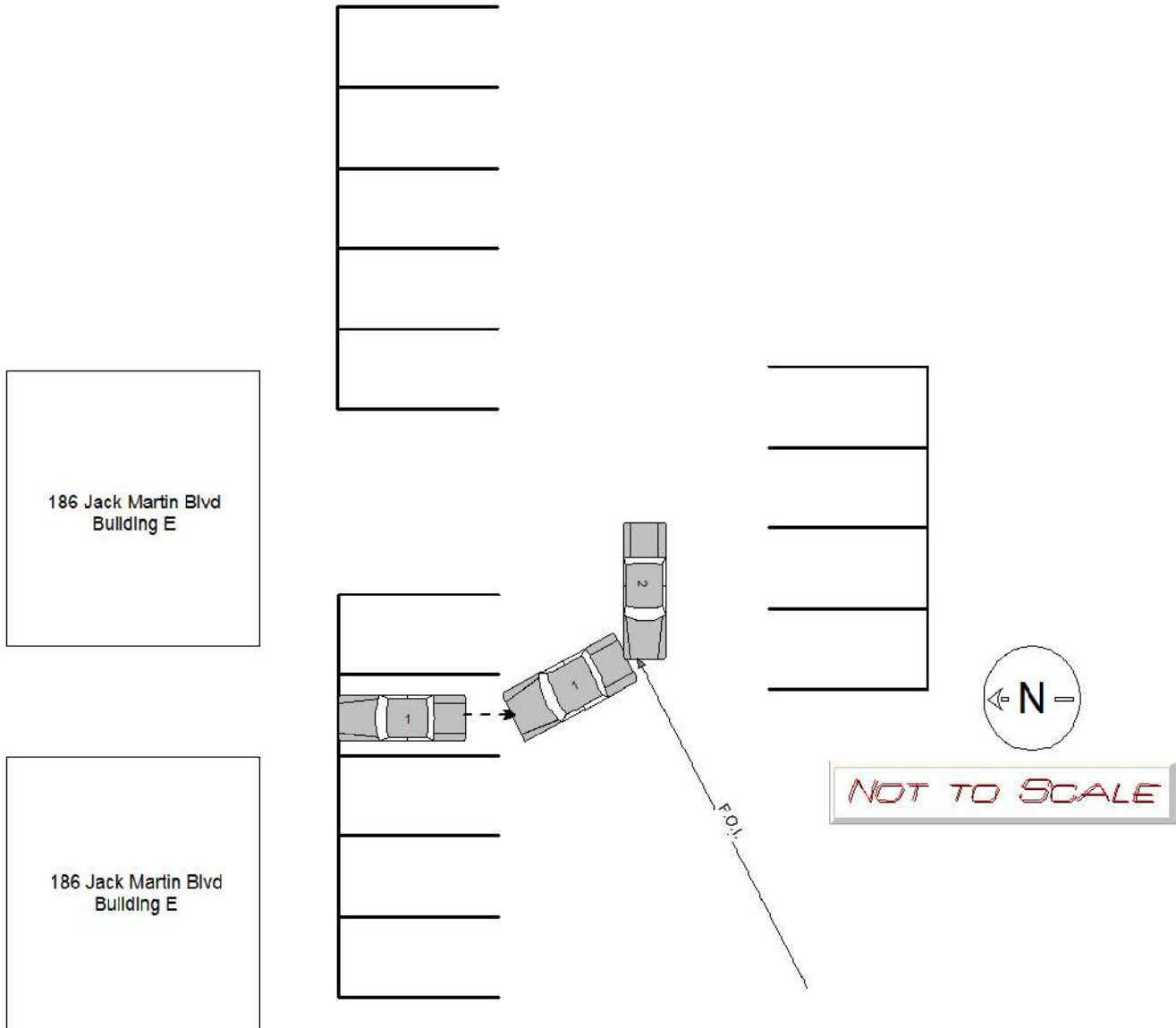
