145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 struck the driver side of vehicle 2 with the rear bumper of the vehicle when vehicle 2 was stopped in the parking lot.

Driver 1 stated the following:

She did not see any vehicles behind her when she looked back so she began to back up. As she backed up, the rear of her vehicle struck another vehicle.

Driver 2 stated the following:

She was stopped in the parking lot of 186 Jack Martin Boulevard and as she looked for a paper on her front passenger seat, the driver side of her vehicle was struck by another vehicle.

It was determined on scene that driver 1 was at fault for the accident.

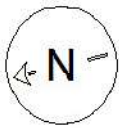

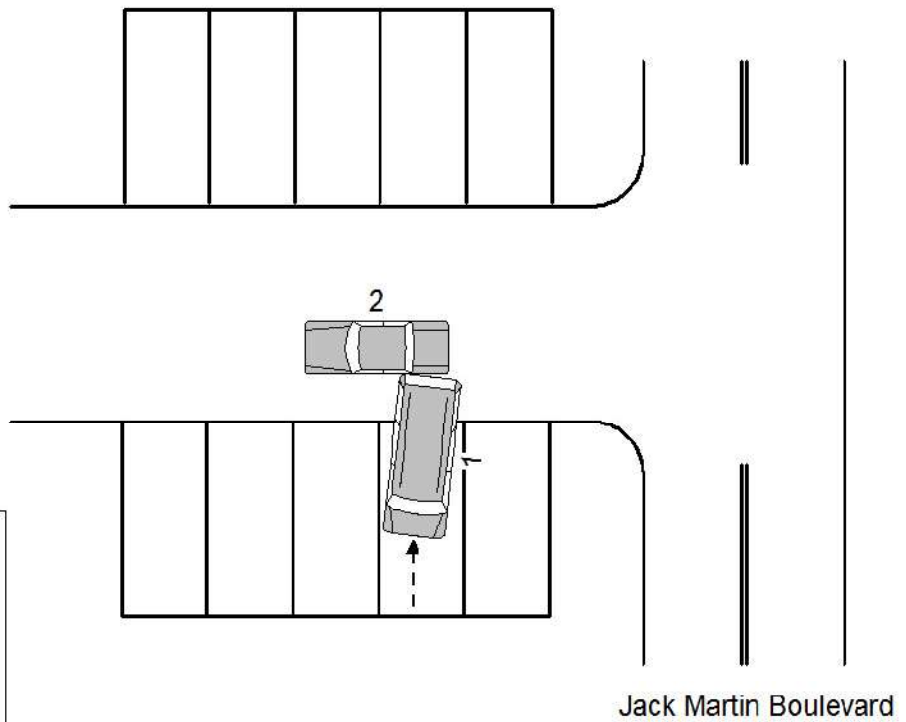
144 Crash Diagram (NOT TO SCALE)
