145. Crash Description/Narrative

Upon arrival, both vehicles were located in the Wendy's parking lot (101 Jack Martin Blvd).

Driver #2 stated she was traveling southbound on Jack Martin Blvd in the area of Route 70 when the traffic in front of her vehicle caused her to slow down. When she had to suddenly slow down, vehicle #1 collided into the rear bumper of vehicle #2 causing minor damage.

Driver #1 stated he was traveling south bound on Jack Martin Blvd directly behind vehicle #2 in the area of the Route 70 intersection. Driver #1 said when the traffic began to slow down, he was unable to stop in time causing the front bumper of his vehicle to collide into the rear bumper of vehicle #2. Vehicle #1 did not have any damage related to this crash.

All parties involved were not injured and refused medical attention.

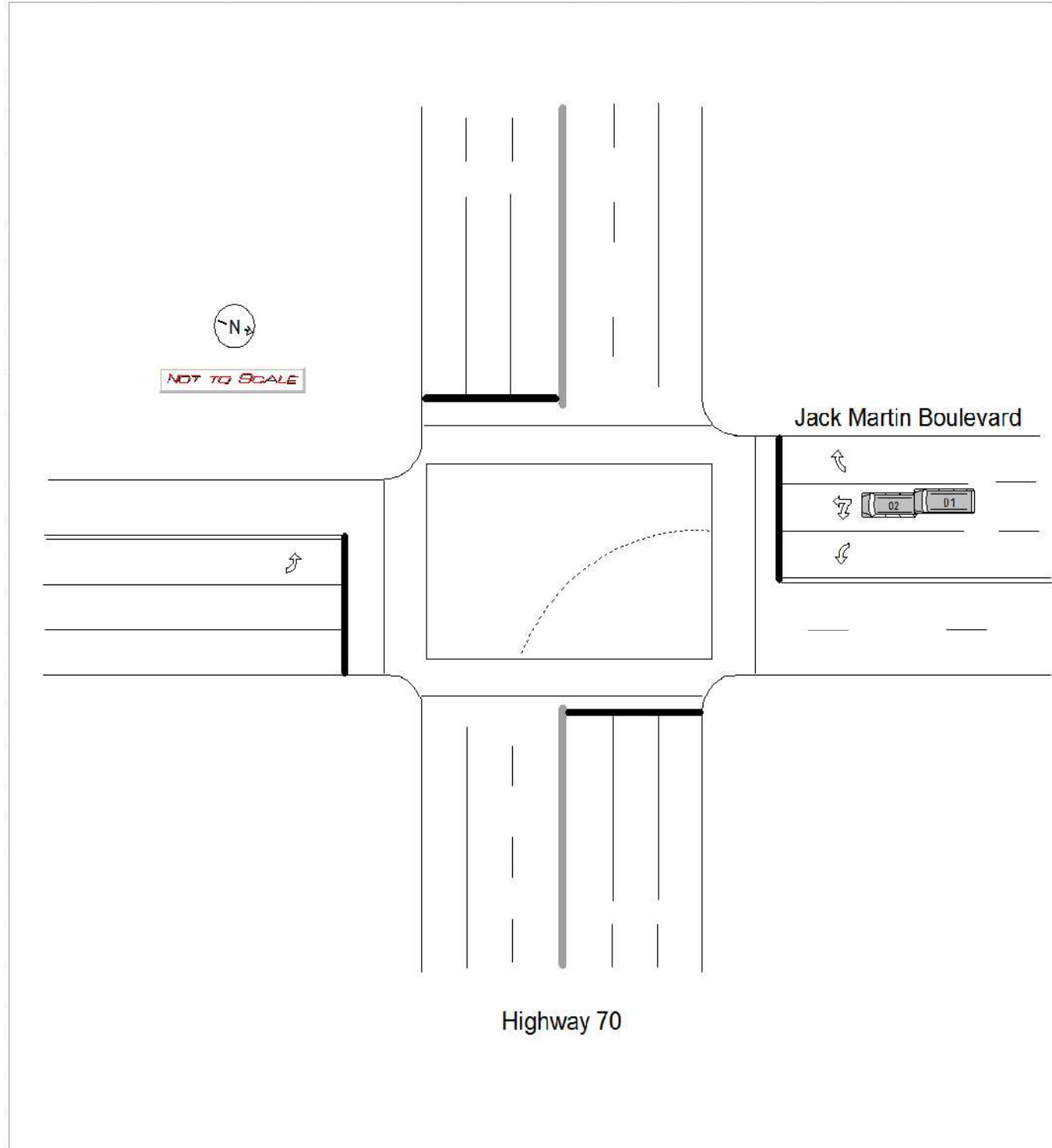
