145. Crash Description/Narrative

Investigation revealed that vehicle #2 was slowing down for traffic which was stopped at the Route 70/Jack Martin intersection when vehicle #1 crashed into the right rear bumper of vehicle #2 with it's left front bumper.

Driver of vehicle #1 stated she saw that vehicle #2 was stopped at the last second and attempted to avoid the accident by driving her vehicle to the right shoulder. She also stated there was a Gatorade bottle which she had been drinking that fell underneath the brake peddle that also caused her not to slow down in time and to crash into the back of vehicle #2.

No injuries were reported on scene and all refused medical attention.

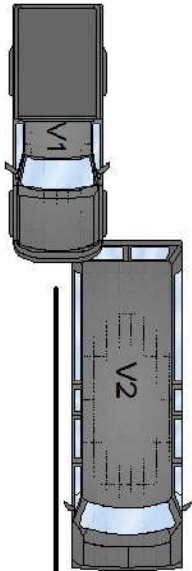

Motor Vehicle Crash Diagram

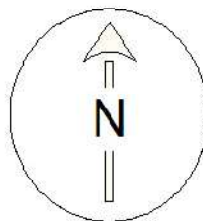
