145. Crash Description/Narrative

Vehicle #1 was stopped waiting to exit the complex of Freeman Orthopedics and make a left turn onto Jack Martin Blvd. Vehicle #2 was traveling North on Jack Martin Blvd. The front of Vehicle #1 collided with the passenger side of vehicle #2, causing moderate damage to both vehicles.

Driver #1 advised he was waiting to make the left turn while at the stop sign. He stated that as he was pulling out, the glare from the sun was directly in his eyes and he could not see Vehicle #2 traveling in front of him.

Driver #2 advised she was traveling North on Jack Martin Blvd when Vehicle #1 suddenly pulled out and collided with the passenger side of her vehicle. While standing there speaking with both parties, I could see how the current position of the sun would be blinding in Driver 1's location at the time of the crash.

Based upon my observations, and statements made by both parties, I find the sun glare and Driver #1's decision to pull out when he could not see to be the reason of the collision. Vehicle #1 was unable to start due to alternator issues prior to the collision, and was towed from the scene.

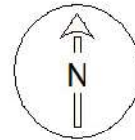

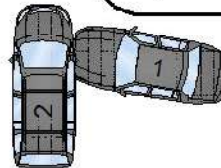
