145. Crash Description/Narrative

On scene investigation revealed that vehicle 1 had made a right on red onto Jack Martin Blvd (North) from Rt 70 (West). Vehicle 2 had the green light from Jack Martin Blvd (North) going through Rt 70. As vehicle 2 proceeded through the intersection vehicle 1 simultaneously made the right turn colliding with vehicle 2. The drivers provided the following statements:

Driver 1 stated she had the red light at Rt 70 westbound as she prepared to make a right turn onto Jack Martin Blvd. Driver 1 stated she did not see vehicle 2 proceeding through the intersection and believed vehicle 2 was speeding up attempting to beat vehicle 1 through the lane merge. Driver 1 did not report any injuries on scene. Vehicle 1 had minor front end damage to the left front driver's side quarter panel. Vehicle 1 was driven from the scene.

Driver 2 stated that she was the first vehicle at the red light on Jack Martin Blvd and Rt 70 (coming from Walmart). She stated the light had turned green and she proceeded through the intersection. She further stated she did not see vehicle 1 make the right turn on red and was struck by vehicle 1 as the lanes merged. Driver 2 and the juvenile occupants did not report any injuries on scene. Vehicle 2 had minor damage to the right middle

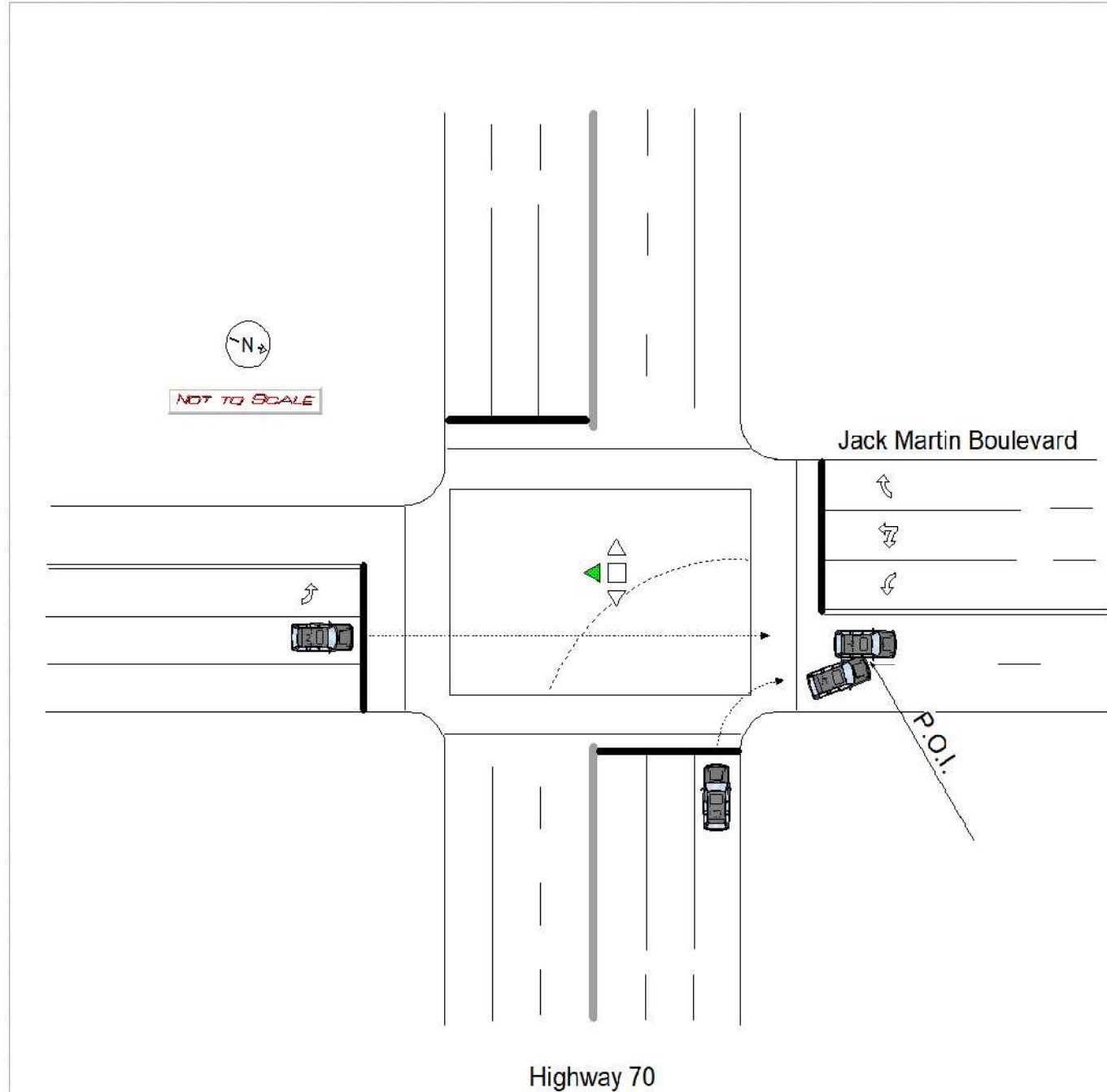
