145. Crash Description/Narrative

Vehicle #1 was traveling east in Wendy's, 101 Jack Martin Blvd., parking lot. While driver #1 was attempting to parking, vehicle #1 left the parking lot over a curb and collided with bushes. Driver #1 stated his foot slipped off the brake while he was attempting to park. He drove over the curb and into the bushes. Subsequently, driver #1 was found at fault for the accident.

It should be noted, upon arrival the passenger was sitting in driver's seat and the driver was later found in Wendy's. Furthermore, the passenger was uncooperative as to how the incident happened. Investigation revealed the true driver (#1) whom was on a NJ Graduated Drivers License Permit and he was forthcoming about the accident.

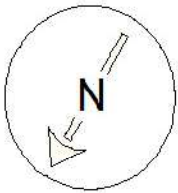
