145. Crash Description/Narrative

The driver of vehicle #1 stated she was attempting to park into a space in the parking lot of The Chelsea, 458 Jack Martin Blvd.. She stated that as she parked, she accidentally hit the gas instead of the brake, causing the vehicle to jump forward. As a result, the vehicle struck a curb, traveled onto the grass and ultimately struck and knocked over a light stand.

No injuries reported and minor damage to vehicle #1.

The light stand was knocked over exposing the electrical wires. Chelsea staff was on location and secured the exposed electrical wires.

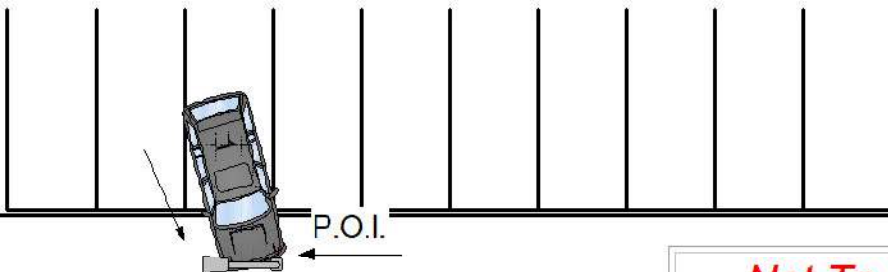
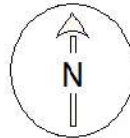
