145. Crash Description/Narrative

Driver of vehicle 1 stated he was parking his vehicle in the parking lot of 466 Jack Martin Blvd. Driver of vehicle 1 reported, while parking he took the turn too wide and struck vehicle 2.

Investigation revealed: Vehicle 1 and 2 were in the parking lot of 466 Jack Martin Blvd. Vehicle 1 was pulling into a parking space as vehicle 2 was unoccupied and parked in a marked parking space. Driver of vehicle 1 was inattentive and struck vehicle 2 causing minor damage to both vehicles.

There were no reported injuries at the time of the investigation.

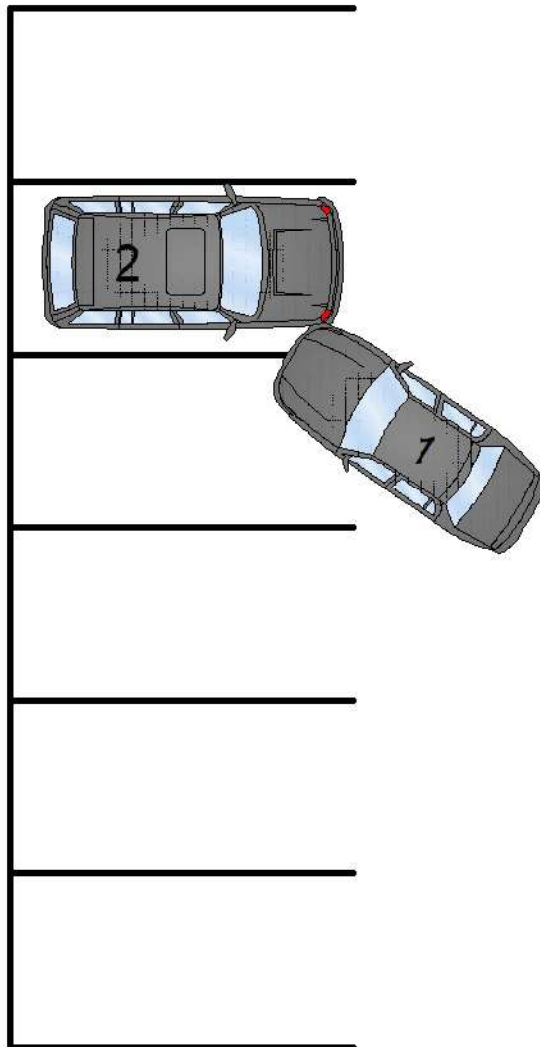
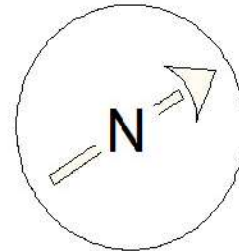
