145. Crash Description/Narrative

Vehicle #1 was traveling north on Jack Martin Blvd. approaching Askin Rd. Another vehicle made a left hand turn out of the Walmart lot in front of Vehicle #1, causing Vehicle #1 to swerve right and crash into a curb.

The driver of Vehicle #1 stated he was traveling north on Jack Martin (near Asking Rd) when a silver Nissan made a left turn out of the Walmart lot in front of him. He explained that had he not swerved, he would have crashed into the Nissan instead of the curb.

Witness to the crash, Laura Townley (732-948-4342) stated that she was behind this other vehicle which she described as being a small silver Nissan, being driven by an older female. She explained that she was behind the Nissan as it left the Walmart lot and that she watched it pull out in front of Vehicle #1 without stopping at the stop sign. This was said to cause Vehicle #1 to strike the curb. Townley added that the Nissan then left the scene.

No injuries were reported on scene

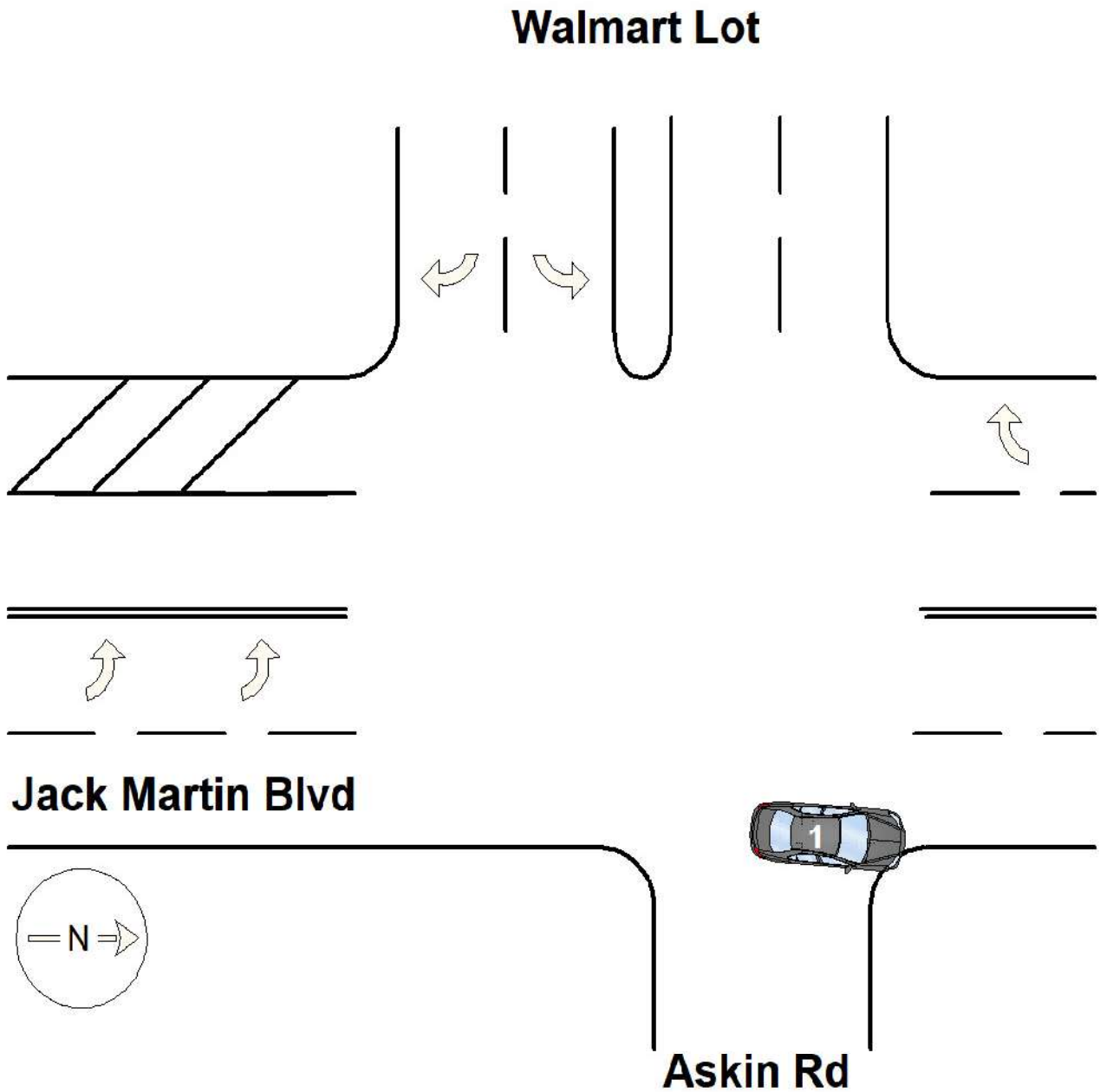
