145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88 directly behind vehicle 2 approaching the intersection of Jordan Road. Vehicle 2 crossed through the intersection and began to slow for traffic ahead. Vehicle 1 sped up in an attempt to make it through the changing light and was not able to slow down for the traffic ahead, rear ending vehicle 2.

Driver 1 stated she was traveling east on Route 88 approaching Jordan Road behind vehicle 2. Driver 1 stated as she began to enter the intersection the light changed to yellow, believing she did not have enough time to stop driver 1 stated she sped up to try and make it through the intersection. Driver 1 stated she then noticed traffic was stopping ahead of her and she was unable to stop in time, rear ending vehicle 2.

Driver 2 stated she was traveling east on Route 88 and had just crossed through the intersection of Jordan Road when she began to slow for traffic ahead of her. Driver 2 stated she was rear ended while she was stopping for traffic by vehicle 1.

Investigation revealed that the cause of the crash was due to driver 1 failing to observe the traffic signal

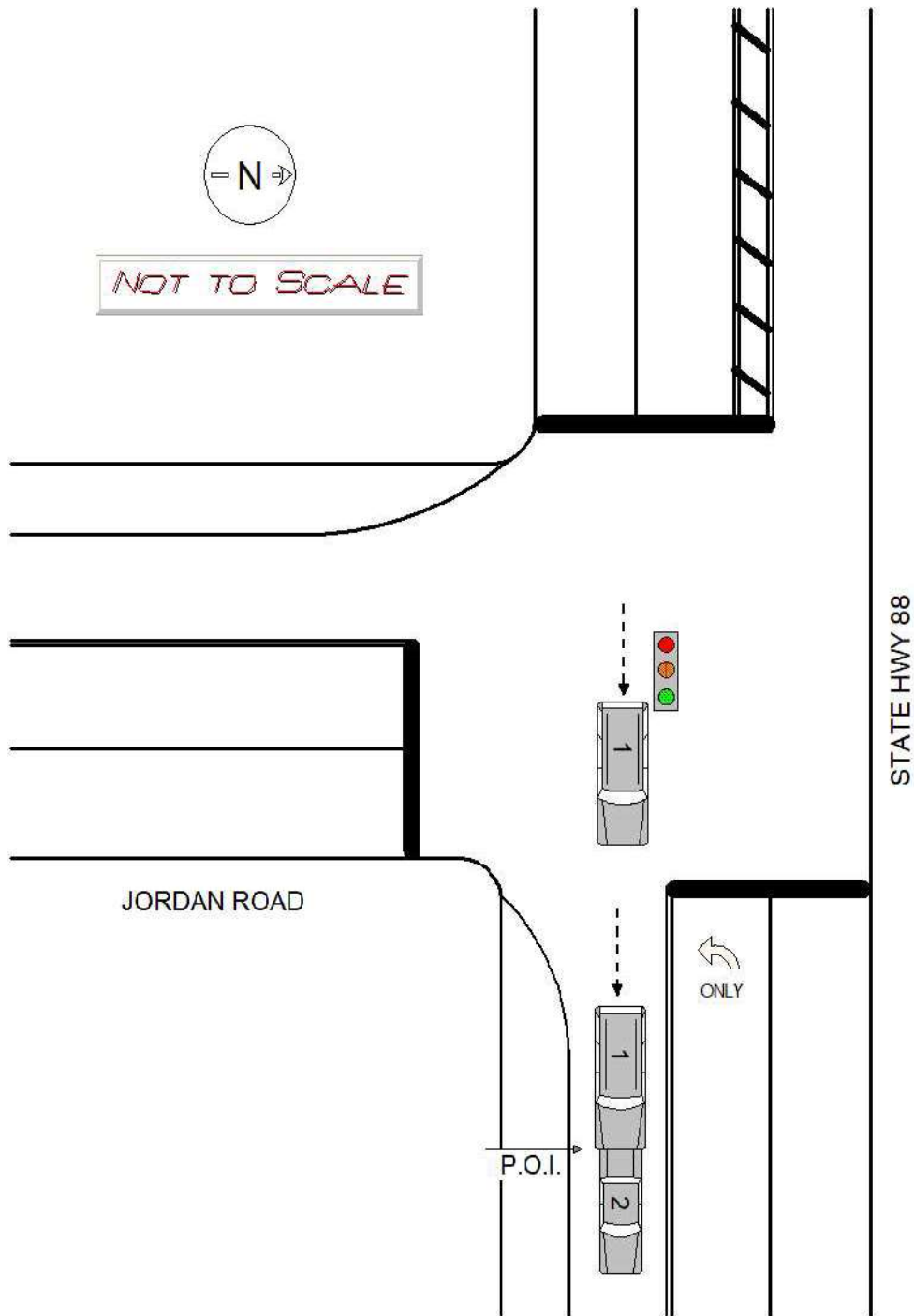
