145. Crash Description/Narrative

On 5/6/19 at 0955 I was proceeding east on Rt 88 approaching Post Rd. when I came across a motor vehicle crash in the roadway. The vehicles passengers claimed they were not injured and did not want first aid. The vehicles were moved into the Laurelton Baptist Church (1832 Rt. 88)

Driver vehicle 1 stated he was in the left lane approaching Post Rd. Vehicle 1 turned on its right turn signal to signal he wanted to change lanes. As vehicle 1 changed lanes it collided with vehicle 2.

Driver vehicle 2 stated she was approaching Post Rd. and steered into the right lane. As she proceeded vehicle 1 changed lanes and collided with her

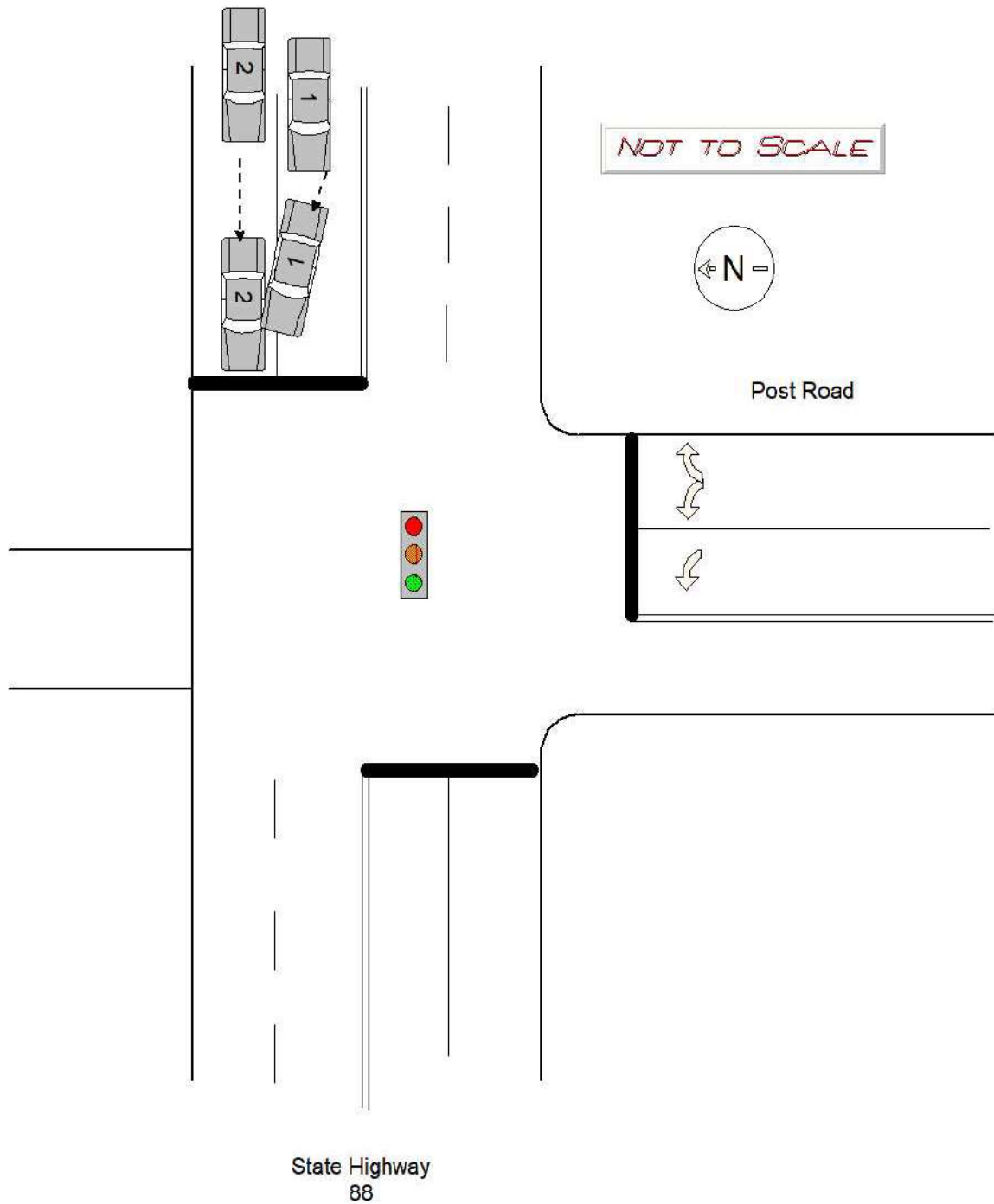
