145. Crash Description/Narrative

Vehicle 1 and 2 were both traveling eastbound on Rt 88. Vehicle 2 stopped due to traffic. Vehicle 1 failed to stop colliding with the rear of vehicle 2. There was no visible damage.

The driver of vehicle 1 advised he was traveling eastbound on Rt 88 behind vehicle 2. Driver 1 further advised he looked down for a brief moment to adjust the vehicle heat. Driver 1 stated vehicle 1 was then stopped in front of him which he collided with.

The driver of vehicle 2 advised she was traveling eastbound on Rt 88. Driver 2 stated traffic stopped in front of her so she stopped as well. Driver 2 was then struck from the rear by vehicle 1.

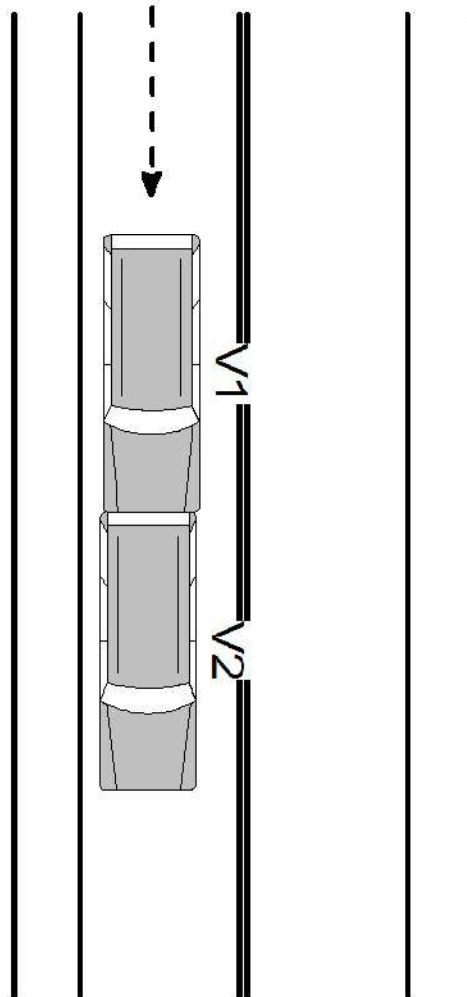
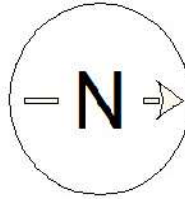
