145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 and Vehicle 2 were both westbound in the right of two lanes on NJ Route 70. Vehicle 1 was traveling directly behind Vehicle 2. Vehicle 2 was slowing in traffic because the vehicles in front of it were stopped. Vehicle 1 was not able to slow as quickly as vehicle 2 causing Vehicle 1 to impact the rear of Vehicle 2.

Driver 1 stated he was traveling behind Vehicle 2 when Vehicle 2 began to slow in traffic. Driver 1 advised he did not expect Vehicle 2 to slow down, hindering his ability to stop in time. In addition, Driver 1 stated his brakes have been giving him trouble and he felt like they did not work properly when he tried to avoid impacting vehicle 2.

Driver 2 stated he was stopped in traffic when he observed Vehicle 1 approaching from behind and not slowing. Driver 2 stated he could not move to avoid being impacted by Vehicle 1.

Vehicle 2 sustained minor damage to the rear bumper.

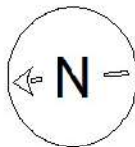

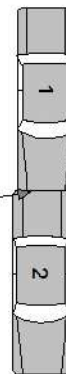
