145. Crash Description/Narrative

V2 was on Burrsville Road at the intersection of Burrsville Road and RT 88. V1 was directly behind V2. Before V2 entered RT 88, the front of V1 struck the rear of V2.

The driver of V2 stated that she was driving East bound on Burrsville Road, directly in front of V1. The driver of V2 stated that she stopped at the intersection of Burrsville and RT 88. The driver of V2 stated that she looked both ways before attempting to pull out onto RT 88 East bound. The driver of V2 stated that after making a complete stop, she began to move forward towards the intersection. The driver of V2 stated that as she moved towards the intersection she was able to see a car traveling West bound on RT 88. The driver of V2 stated that she did not feel it was safe for her to pull out in front of the vehicle. The driver of V2 stated that she stopped and did not enter the intersection. The driver of V2 explained that after she stopped, the front of V1 hit the rear of V2.

The driver of V1 stated that she was directly behind V2 at the intersection of Burrsville Road and RT 88. The driver of V1 stated that V2 made a complete stop and then began to travel into the intersection. The driver of V1 stated that she then looked left and right and began to enter the intersection. The driver of V1 stated that the

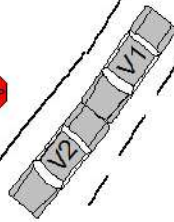
