145. Crash Description/Narrative

Vehicle#1 was traveling west on Route 88 near the intersection of Kenneth Place. Vehicle#2 was traveling directly in front of Vehicle#1. Driver#2 came to a complete stop in order to make a left turn into the business located at the corner of Route 88 and Kenneth Place (1925 Route 88). Vehicle#1 failed to come to a complete stop and struck Vehicle#2. Driver#2 then proceeded to turn left onto Kenneth Place at which time Vehicle#1 continued west on Route 88. A witness followed Vehicle#1 and was able to obtain the vehicle's license plate. The witness advised that he observed a younger white male operating Vehicle#1 (late teens, early twenties). Vehicle#1 is registered to a female out of Jackson NJ. Jackson Police were notified and advised they would attempt to locate Vehicle#1 and identify the driver. Driver#2 stated that when she came to a stop she was struck at which time she pulled onto Kenneth Place to wait for Vehicle#1. Once on Kenneth Place Vehicle#1 fled the area. Driver#2 complained of neck pain but refused first aid. Vehicles were moved prior to arrival.

A few hours later Driver#1 contacted Police Headquarters and provided his driver's license information as well as his insurance information. When asked why Driver#1 left the scene he advised due to airbag deployment. Driver#1 was issued summonses for Leaving the Scene, Failure to Report and Careless Driving, which were mailed to his home address.

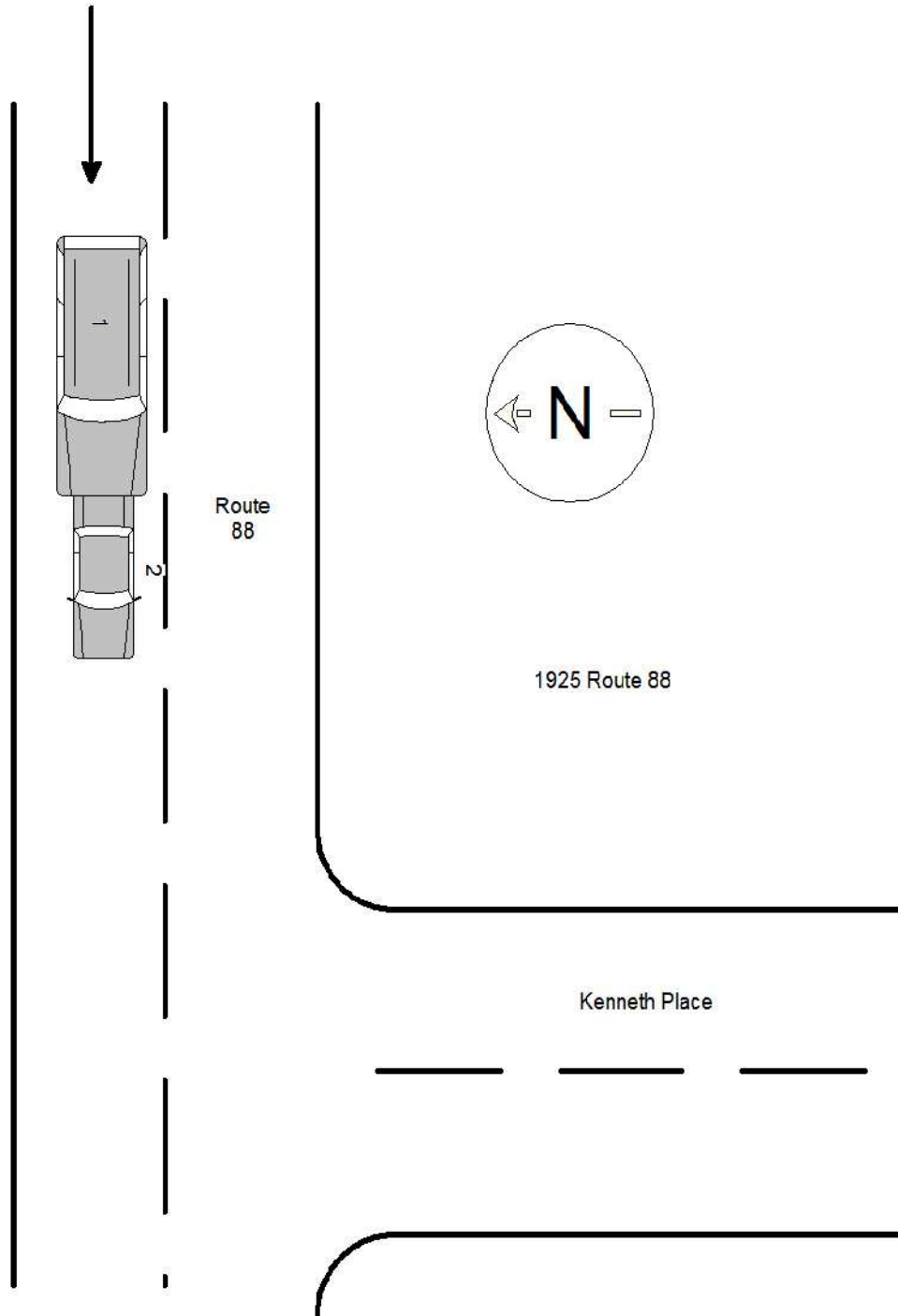
