145. Crash Description/Narrative

Vehicle 1 was stopped at a stop sign on Midstreams Place waiting to make a left onto RT 88 wb. Vehicle 2 was traveling east on RT 88 approaching Midstreams Place. Vehicle 1 proceeded with a left turn and entered Vehicle 2's lane of travel, causing Vehicle 2's front to crash into the front left of Vehicle 1.

Driver 2 stated same as above.

Driver 1 stated prior to starting his left turn he observed Vehicle 2 approaching and thought there was enough distance to proceed safely. Driver 1 apologized for his miscalculation and advised me his main concern was that Driver 2 was ok.

No injuries were reported by either party. Vehicle 2 was driven from the scene and Vehicle 1 was disabled as a result of the crash and subsequently towed. Driver 1 was issued a summons for careless driving.

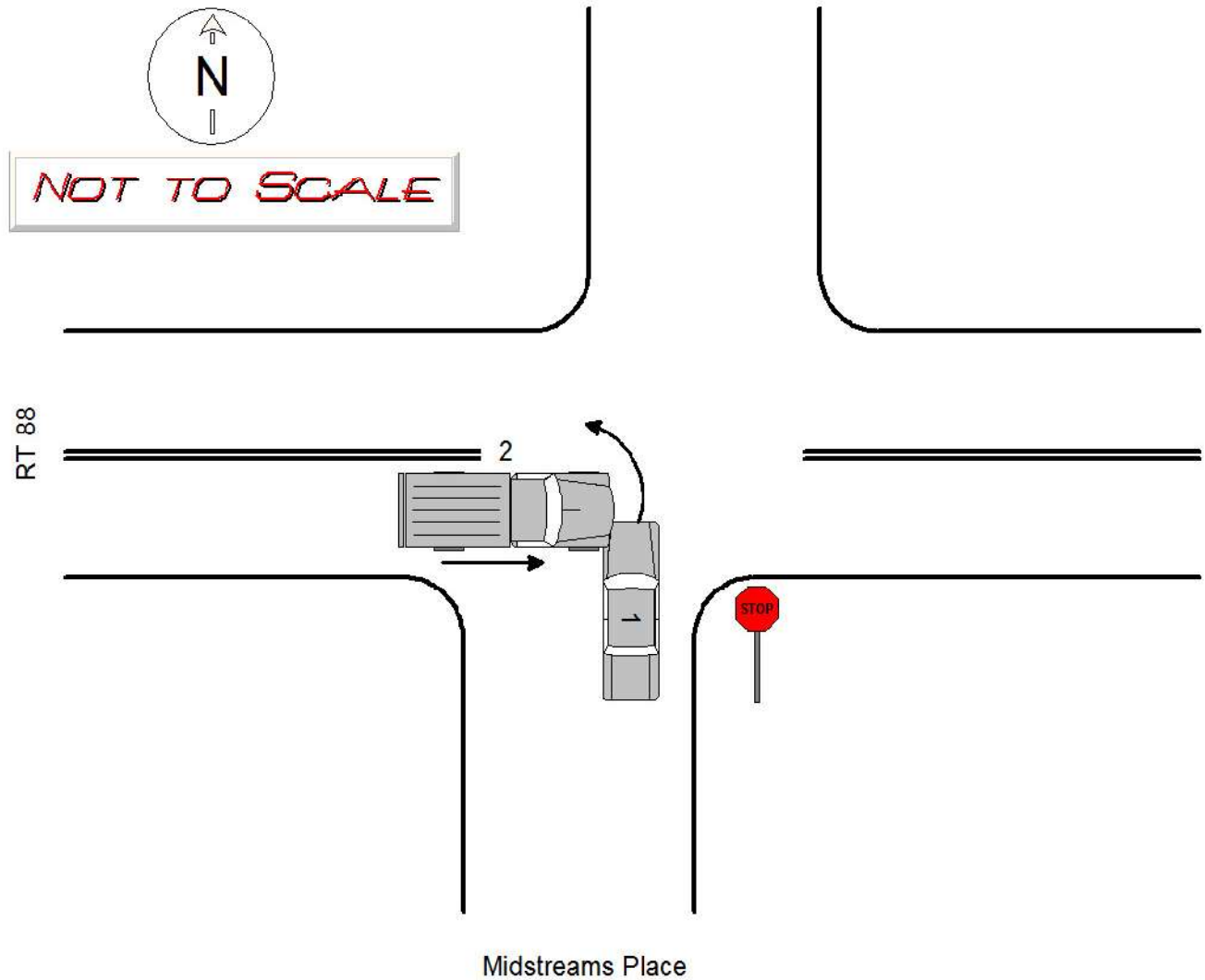
