145. Crash Description/Narrative

On scene investigation reveled the following: Vehicle 1 was making a left turn out of the parking lot of Home Depot (1722 RT 88). Vehicle 2 was traveling west on Olden St. Vehicle 1 failed to observe Vehicle 2 traveling in the left lane of travel on Olden St, causing it to crash in to vehicle 2.

The Driver of Vehicle 2 stated the following: While driving down Olden St towards Rt. 88, vehicle 1 pulled out of Home Depot and struck her vehicle. She was not injured nor had a complaint of pain on scene.

On scene I observed minor damage to the front passenger side bumper of vehicle 2

The driver of vehicle 1 stated the following: While waiting to pull of Home Depot he was waved on by another vehicle traveling east on Olden St. When he began to make his turn he failed to see vehicle 2 and struck her vehicle. He was not injured nor had a complaint of pain on scene.

On scene I observed minor damage to the front bumper of Vehicle 1.

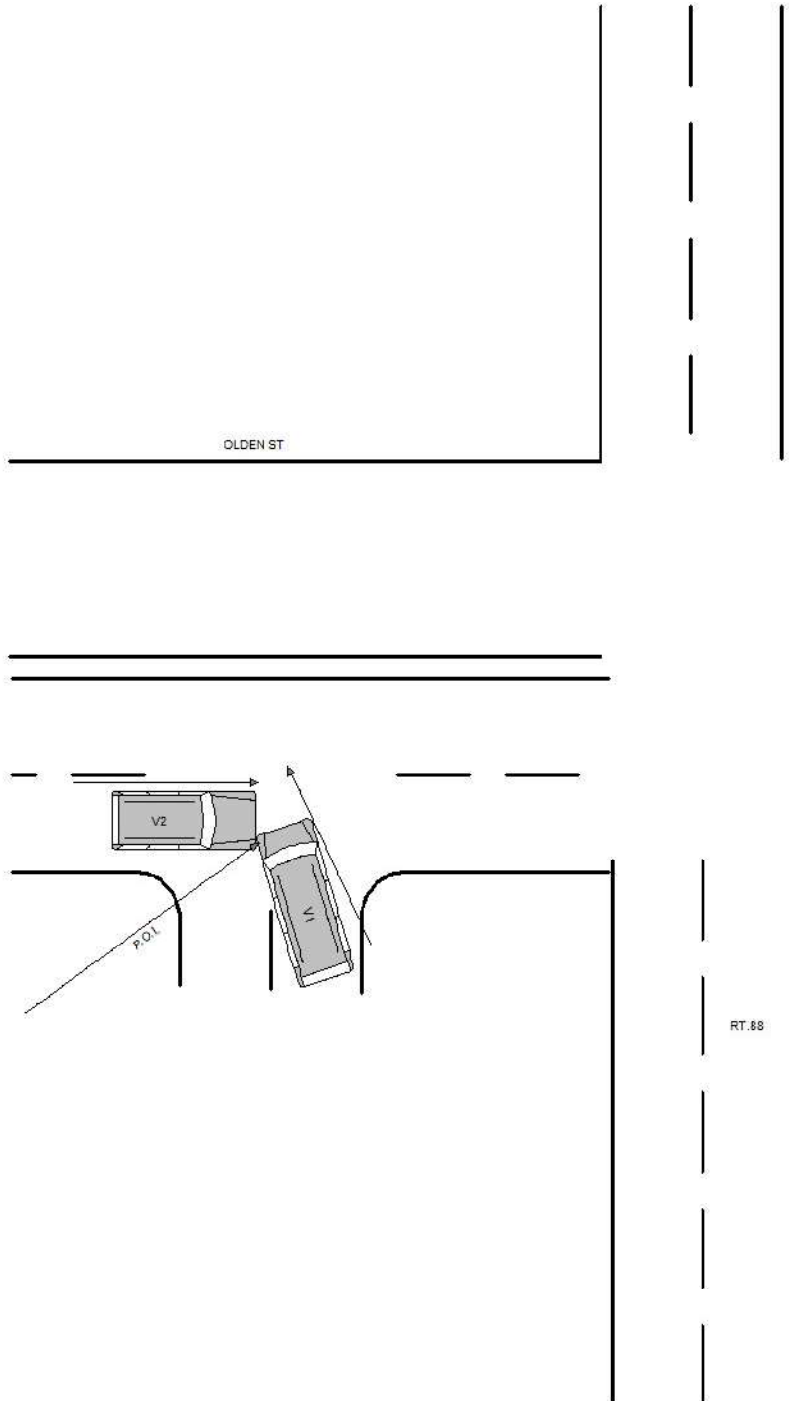
