145. Crash Description/Narrative On scene investigation concluded: Vehicle #1 and #2 were traveling in the parking lot of Brick Hospital, 425 Jack Martin Blvd. Vehicle #1 had stopped at stop sign in the parking lot but was stopped middle of the road, occupying both lanes of travel as it prepared to turn left onto the exit road. Vehicle #2 was attempting to turn right in the direction from which Vehicle #1 was coming from. Vehicle #2 stopped before turning right, due to the roadway being blocked by Vehicle #1 and Vehicle #1 proceeded to make the left turn towards Jack Martin Blvd. Vehicle #1 made the left turn and struck Vehicle #2 as it was stopped. Driver of Vehicle #1 advised she had stopped at the stop sign prior to turning left to exit 425 Jack Martin Blvd. toward Jack Martin Blvd. Driver of Vehicle #1 relayed she began to turn left, did not observe Vehicle #2 stopped and struck Vehicle #2. Driver of Vehicle #1 relayed the sun glare may have caused her to fail to see Vehicle #2. Driver of Vehicle #2 advised she was attempting to turn right in the parking lot of 425 Jack Martin Blvd. when she observed Vehicle #1 occupying both lanes of travel. Driver of Vehicle #2 relayed she stopped, waited for Vehicle #1 to turn left and when it began to turn left it struck her vehicle.

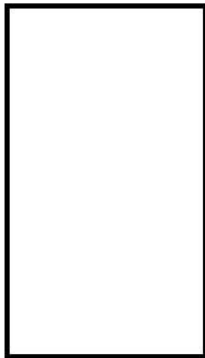

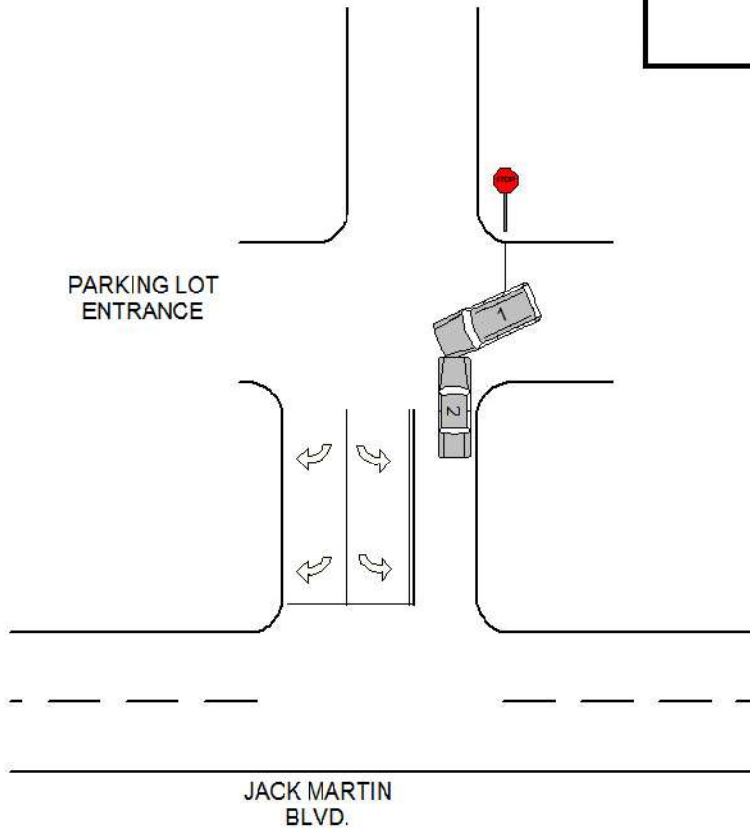
