145. Crash Description/Narrative

A motor vehicle crash occurred in the parking lot of Jersey Shore Vascular Institute located at 425 Jack Martin Blvd.

Driver of Vehicle #1 advised he was backing out of his parking spot. Driver #1 advised he was struck by Vehicle #2 while in reverse.

Driver of Vehicle #2 advised she was backing out of her parking spot. The vehicle (Vehicle #1) did not observe her backing out of her parking spot and struck her while in reverse.

There were no reported injuries while on scene.

Both vehicles were in reverse during the time of the crash. The damage was approximately 1 foot past the line of Vehicle #1's parking spot. Vehicle #1 is the at fault driver for backing unsafely and driver inattention.

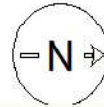

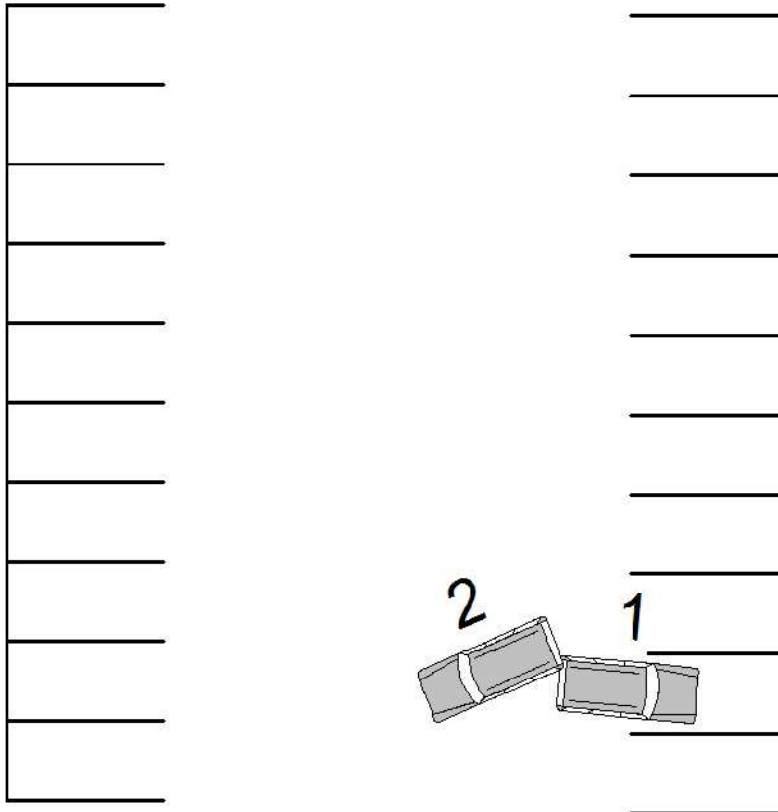
144 Crash Diagram (NOT TO SCALE)
