145. Crash Description/Narrative

Vehicle 2 was traveling west on Jack Martin Boulevard and stopped waiting for traffic with his left turn signal on to turn into a parking lot. Vehicle 1 was traveling west on Jack Martin Boulevard behind vehicle 2 and attempted to pass vehicle 2 on the right. Vehicle 1 collided with vehicle 2 while attempting to pass.

Driver 1 stated she was traveling west on Jack Martin Boulevard and she observed vehicle 2 stopped in front of her with it's left turn signal on. Driver 1 stated she attempted to pass vehicle 2 on the right but due to a glare she mis-judged and collided with vehicle 2.

Driver 2 stated he was traveling west on Jack Martin Boulevard and he was stopped with his left turn signal on to turn into a parking lot. Driver 2 stated he believed vehicle 1 could not see him due to a glare and it caused her to collide with his vehicle.

Investigation revealed that the cause of the crash was ultimately due to driver 1 attempting to pass vehicle 2 improperly, on the right.

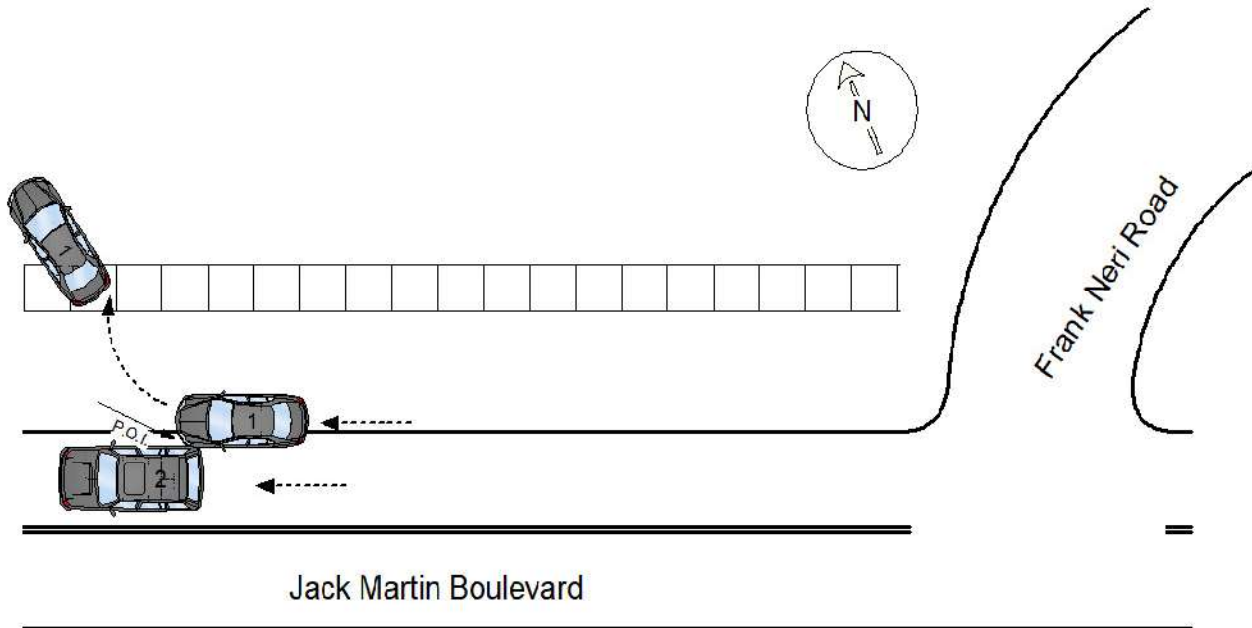
