145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was in the parking lot of 415 Jack Martin Blvd. approaching a T-intersection. Vehicle 2 was in the same lot approaching the same intersection. Both vehicles entered the intersection at the same time and vehicle 1 struck the rear passenger side of vehicle 2. Based upon the direction of travel Vehicle 2 had the right of way at the intersection.

Driver 1 stated she was in the parking lot for 415 Jack Martin Blvd. and was unfamiliar with the area. AS she approached the T-intersection she did not realize that was an intersection with an additional part of the parking lot. She continued into the intersection and subsequently struck the rear passenger side of vehicle 2.

Driver 2 stated she was driving straight attempting to exit the lot. Vehicle 1 attempted to enter the roadway at an intersection where she had the right of way. She observed vehicle 1 and attempted to avoid the collision but was unable to do so.

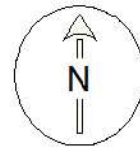
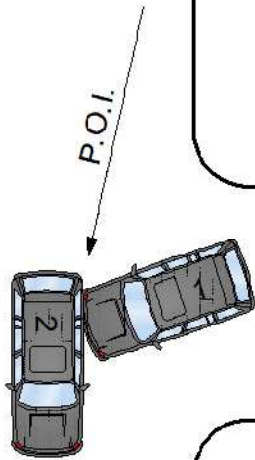
