145. Crash Description/Narrative

Vehicle 2 was stopped at the drive through window at Wendy's, 101 Jack Martin Boulevard. Vehicle 1 was stopped directly behind vehicle 2. Vehicle 1 rear ended vehicle 2.

Driver 2 stated he was stopped at the drive through window at Wendy's when vehicle 1 rear ended him.

Driver 1 stated he was stopped directly behind vehicle 2 in the drive through at Wendy's when his foot slipped off the brake pedal and he subsequently rear ended vehicle 2.

Investigation revealed that the cause of the crash was due to driver 1's inadvertent action of his foot slipping off the brake pedal, causing his vehicle to move forward and collide with vehicle 2.

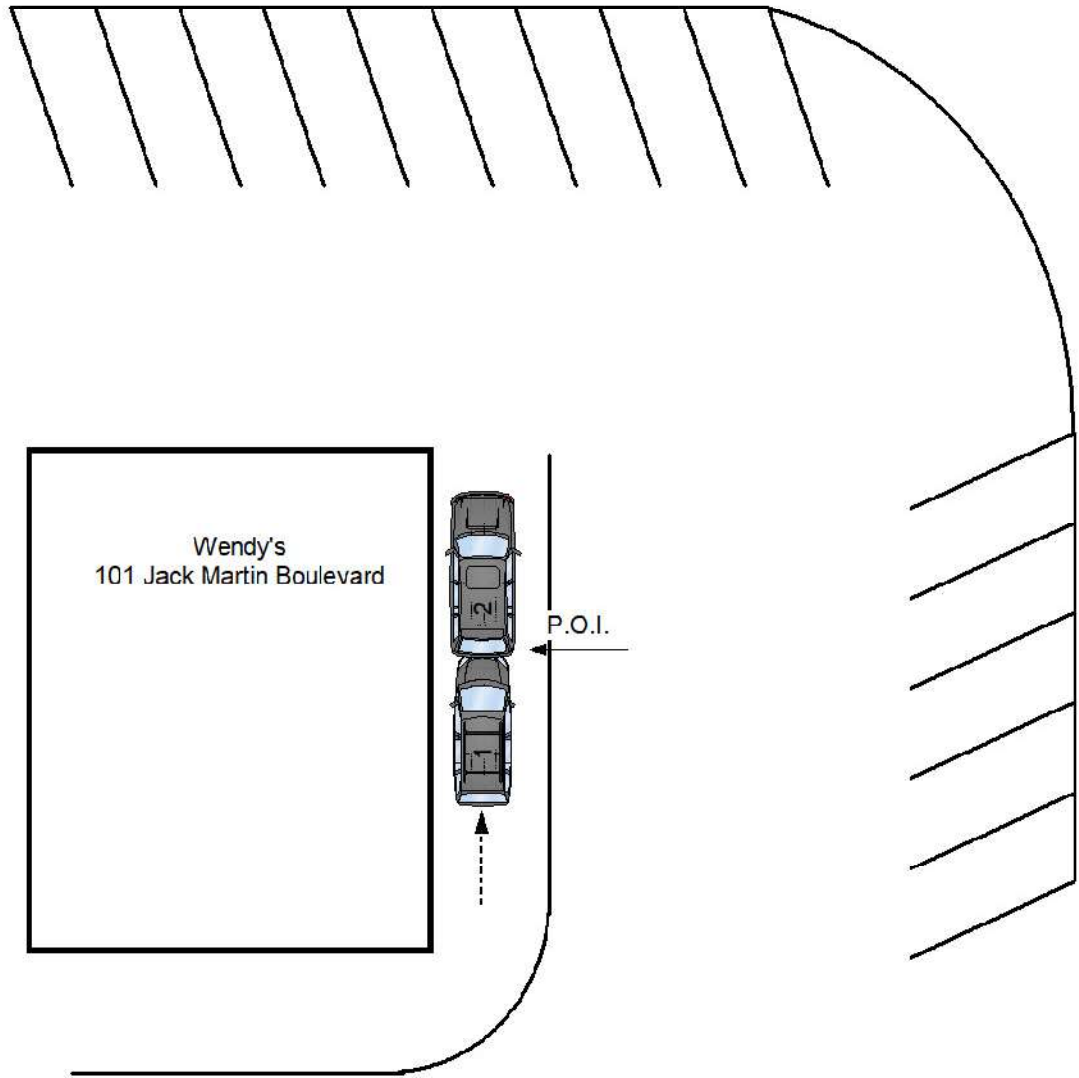
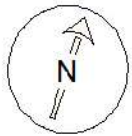
