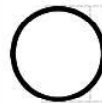

145. Crash Description/Narrative

Vehicle 1, vehicle 2, and vehicle 3 were all waiting in the drive thru located at Wendy's (101 Jack Martin Boulevard). Vehicle 3 was in the front of the line, vehicle 2 was behind vehicle 3, and vehicle 1 was behind vehicle 2. Vehicle 1 accelerated while behind vehicle 2, causing the front driver side corner of vehicle 1 to strike the rear passenger side corner of vehicle 2. This initial motor vehicle collision then caused the front of vehicle 2 to be pushed into the rear of vehicle 3. A moderate amount of damage was observed on the front driver side corner of vehicle 1. A moderate amount of damage was also observed on the rear passenger side corner of vehicle 2. A minor amount of damage was observed on the rear bumper of vehicle 3.

While on scene, there were no reported injuries and all parties refused medical attention.

Driver 1 advised he was waiting in the Wendy's drive thru behind vehicle 2. Driver 1 stated he was handing his brother their dog when he observed the line ahead of him begin to move. Driver 1 said he thought his foot was on the brake pedal but advised he accidentally put his foot on the gas pedal. Driver 1 said this caused vehicle 1 to accelerate and strike vehicle 2. This in turn pushed vehicle 2 into vehicle 3.

145 Crash Description

Driver 2 advised he was waiting in line at the Wendy's drive thru behind vehicle 3 when he observed vehicle 3 begin to move. Driver 2 stated he then felt a jolt when vehicle 1 struck vehicle 2. Driver 2 said the collision with vehicle 1 caused vehicle 2 to be pushed into vehicle 3.

Driver 3 advised she had just gotten her food via the Wendy's drive thru and was in the process of moving out of the drive thru lane. Driver 3 stated she then felt a jolt when the front vehicle 2 struck the rear of vehicle 3.

Through my investigation, I find driver 1 to be at fault for following too closely and driver inattention. Driver 1 was issued 1506 E100512 in violation of 39:4-97.

*Driver 2 was unable to provide a valid driver's license and insurance information. Driver 2 was issued 1506 E100513 in violation of 39:3-10B. Driver 2 was also advised to send a his insurance information to my workplace email by the following day or he would be issued an additional traffic citation.

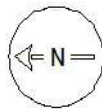

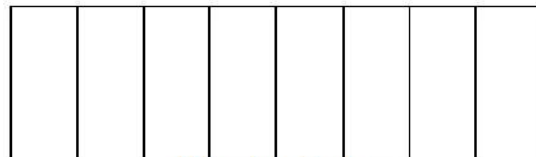
