145. Crash Description/Narrative

Investigation at the scene revealed the following: Vehicle #2 was stopped at a yield sign on the Rt. 88/Rt. 70 ramp awaiting to merge onto Rt. 70 westbound. Vehicle #1 was behind Vehicle #2. The driver of Vehicle #1 believed Vehicle #2 merged onto Rt. 70 westbound. Vehicle #1 proceeded forward and struck the rear of Vehicle #2 with the front of its vehicle.

Driver #2 stated the following: He was stopped at a yield sign on the Rt. 88/Rt. 70 ramp awaiting to merge onto Rt. 70 westbound. He was then struck in the by Vehicle #1

Driver #1 stated the following: He was stopped behind Vehicle #2. He believed Vehicle #2 merged into traffic and began to move forward. He then struck the rear of Vehicle #2 with the front of his vehicle.

Both vehicle's were moved prior to my arrival. Driver #2 had a complaint of pain to his back but refused medical attention. Driver #1 did not report any injuries while on scene. Both vehicle's had minor scratches from the collision.

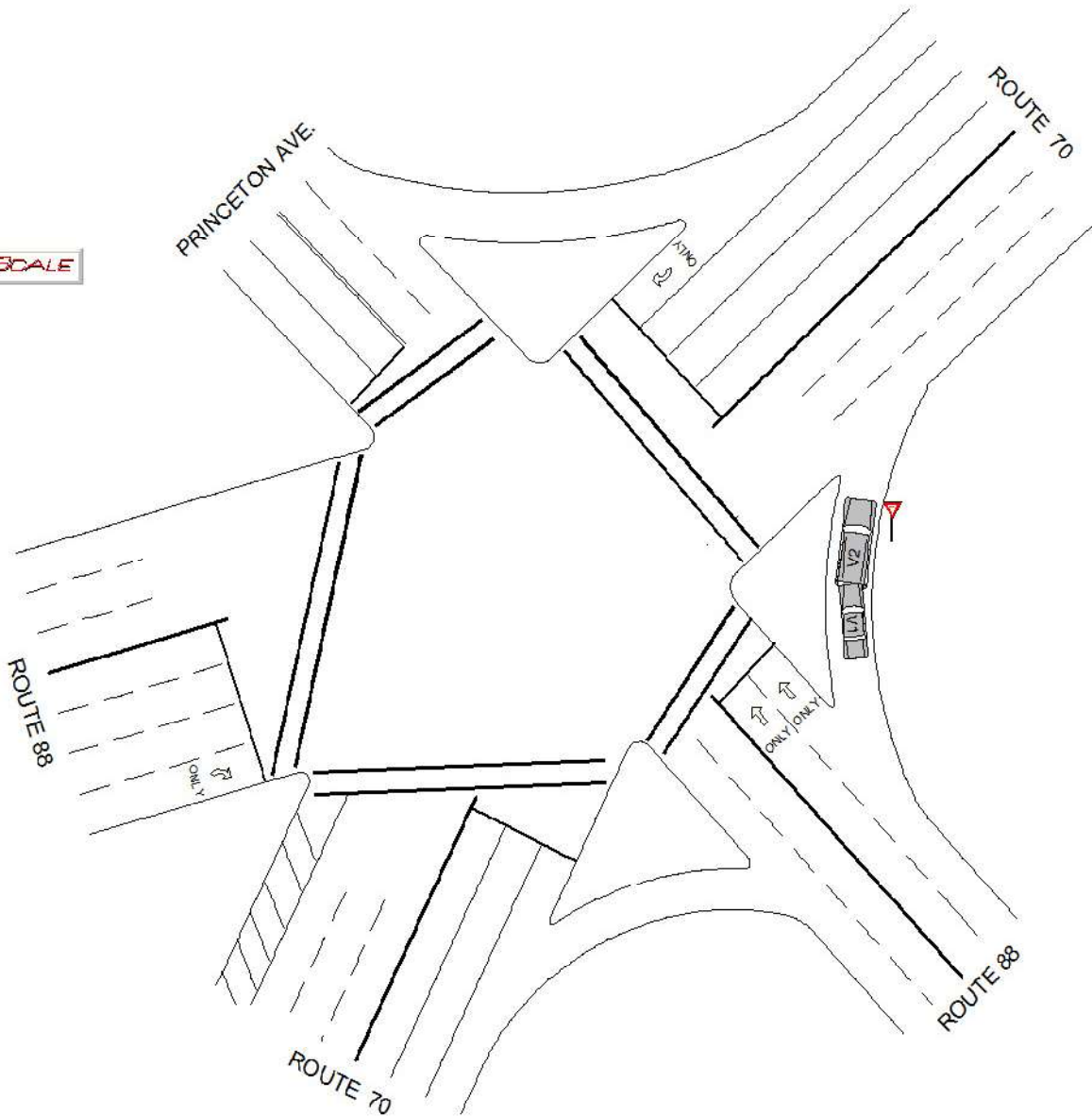
