145. Crash Description/Narrative

The driver of vehicle 2 was stopped on the ramp from Route 88 to Route 70 when the driver of vehicle 1 collided with the rear of vehicle 2.

The driver of vehicle 1 advised she was in traffic on the ramp from Route 88 to Route 70 attempting to merge in traffic. As she continued forward onto Route 70 the front of her vehicle collided with the rear of vehicle 2 which was still stopped in traffic on the ramp.

The driver of vehicle 2 advised she was stopped on the ramp from Route 88 to Route 70 in traffic when the driver of vehicle 1 collided with the rear of her vehicle.

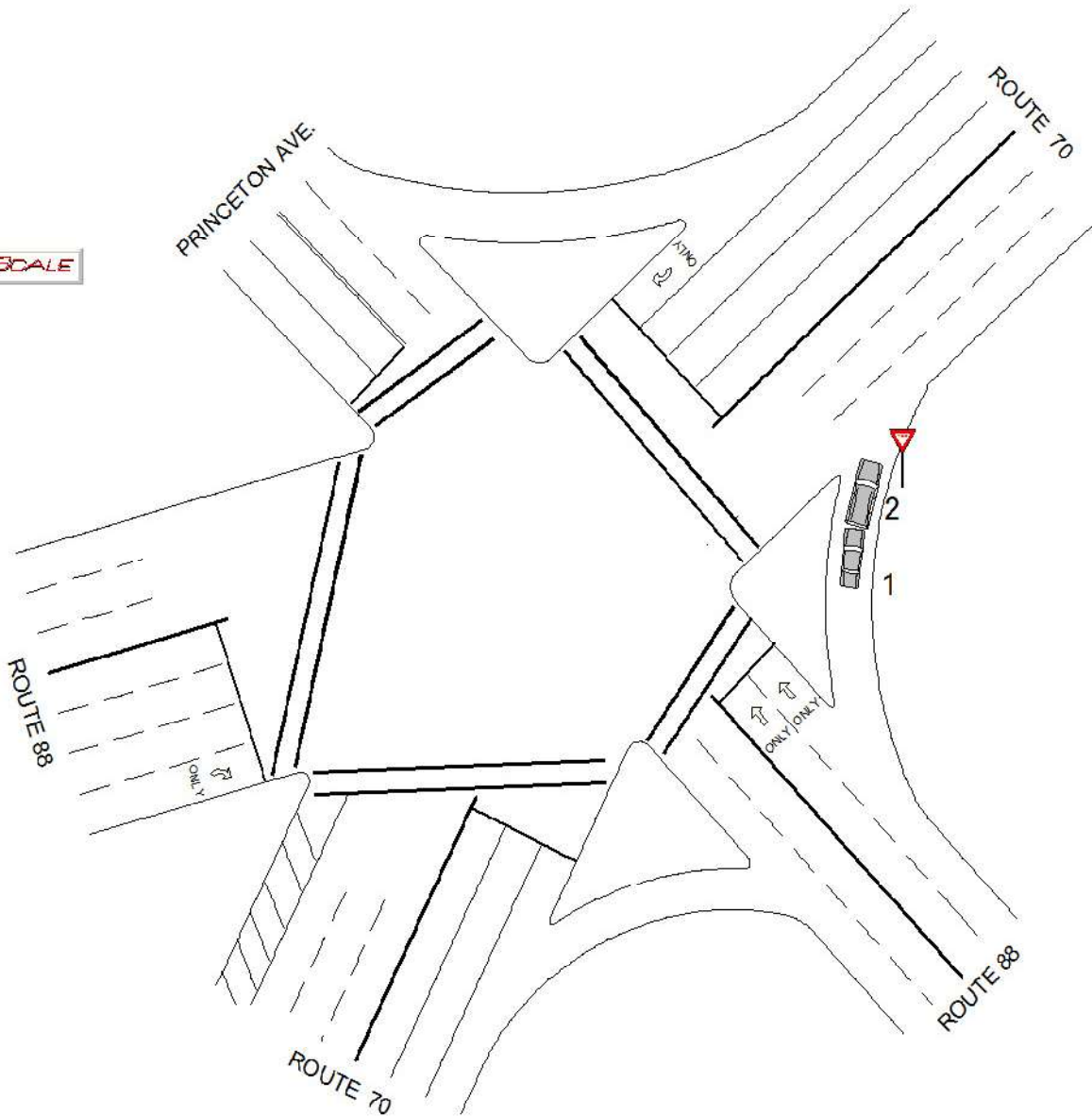
