145. Crash Description/Narrative

Vehicle 3 stopped in traffic, Route 88 eastbound at the entrance/exit of Walmart, 1872 Route 88 prior to Jack Martin Boulevard. Vehicle 2 stopped directly behind Vehicle 3. Vehicle 1 traveling eastbound directly behind Vehicle 2.

Driver 3 stated she was stopped behind an unknown vehicle waiting to turn left into the Walmart parking lot when she felt the impact of being stuck from behind by Vehicle 2. Driver 3 had a complaint of right shoulder pain.

Driver 2 stated she was stopped directly behind Vehicle 3 when she felt the impact of being struck from behind by Vehicle 1. Driver 2 stated the impact pushed Vehicle 2 into the rear of Vehicle 3. Driver 2 had a complaint of whole body pain.

Driver 1 stated she was traveling eastbound on Route 88, directly behind Vehicle 2 and had a lot on her mind. She did not see the stopped vehicles and struck the rear of Vehicle 2 with the front end of her vehicle. Driver 1 had a complaint of chest pain, believed to have been caused by the air bag deploying.

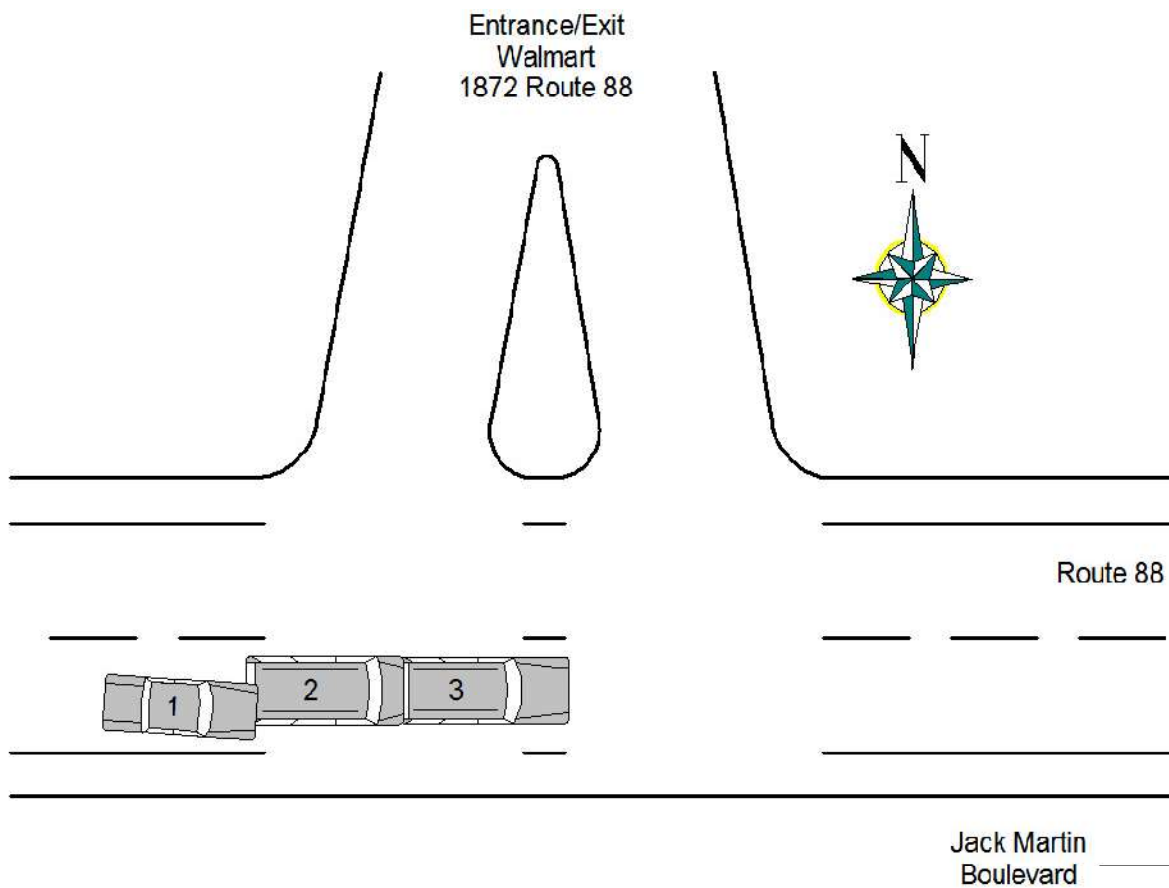
