145. Crash Description/Narrative

Vehicle 2 was parked in a parking stall, in the lot of 2138 Route 88, Dunkin Donuts. Owner/Operator of Vehicle 2

was sitting in Vehicle 2 at the time. Vehicle 1 was attempting to park in a parking stall to the right of

Vehicle 2. Vehicle 1 struck Vehicle 2, causing damage.

Driver 1 stated that prior to the crash, he was attempting to park in the parking stall to the right of Vehicle 2.

He further stated that he misjudged the distance between Vehicle 1 and Vehicle 2.

Vehicle 2 was occupied at the time by Kevin Thomas Smith, 59 Markham Road, Brick, New Jersey, 08724, date of birth

04-22-1950, 732-887-3092. Smith stated that he was not injured at the time.

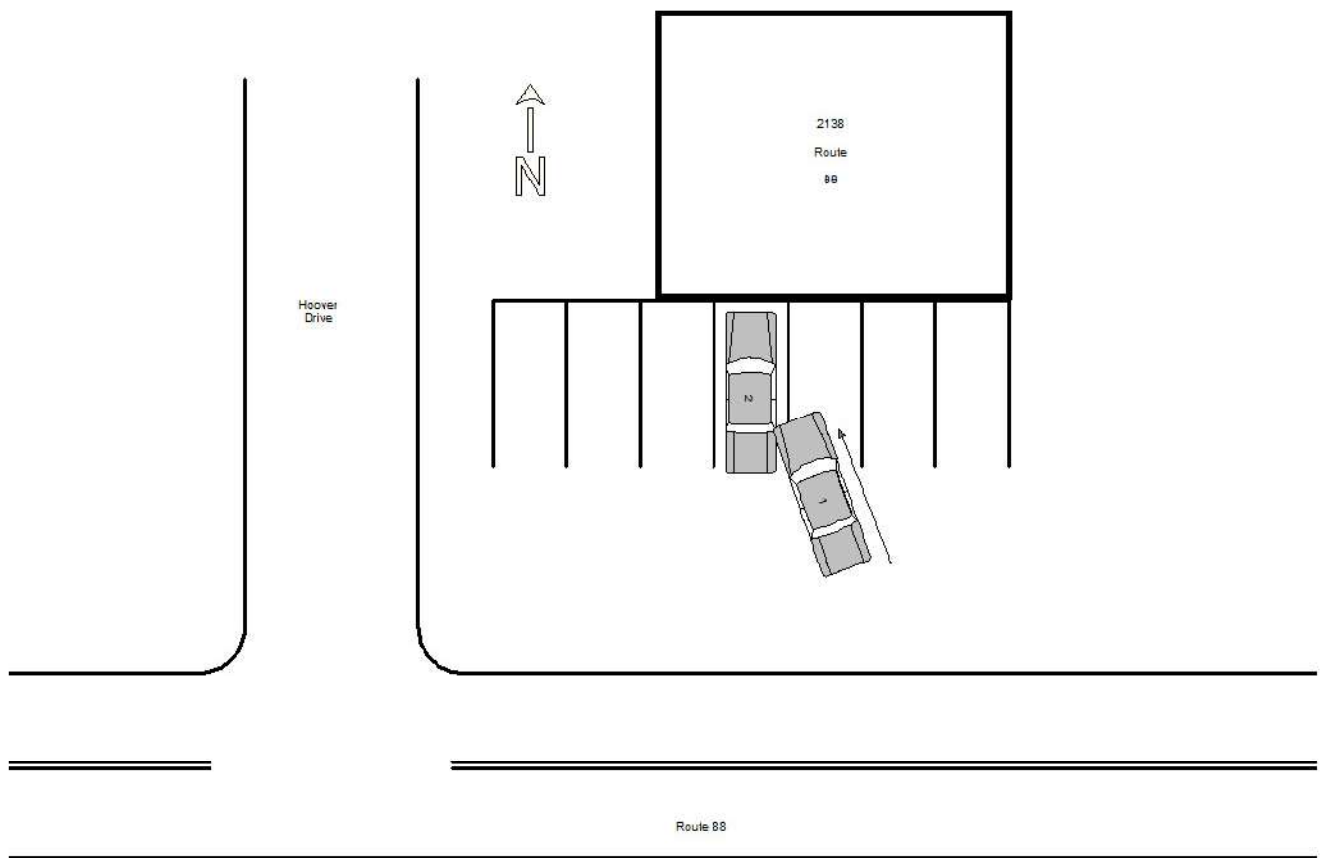
