145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 was exiting the parking lot of the Bagel Exchange, 2030 Rt. 88 attempting to turn left onto Rt 88 (Eastbound). Vehicle #2 was traveling on Rt. 88 (Westbound) when Vehicle #1 entered the roadway to make the left turn without yielding the right of way to Vehicle #2. Vehicle #2 attempted to swerve right to avoid Vehicle #1 but struck Vehicle #1 as it entered the roadway.

Driver of Vehicle #1 advised he was exiting the parking lot of 2030 Rt. 88 attempting to traveling on Rt. 88 (Eastbound). Driver of Vehicle #1 advised he observed Vehicle #2 in the distance, believed he could enter the roadway without issue and began his turn. Driver of Vehicle #1 advised Vehicle #2 did not observe him and struck his vehicle as he entered the roadway.

Driver of Vehicle #2 advised he was travelling on Rt. 88 when Vehicle #1 turned out in front of his vehicle from a business driveway. Driver of Vehicle #2 relayed he attempted to swerve right to avoid the collision but was unable to and struck Vehicle #1.

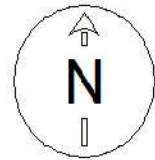

Motor Vehicle Crash Diagram

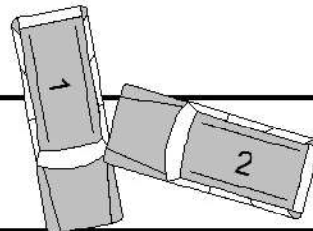
