145. Crash Description/Narrative

Vehicle 1 sustained minor damage to the passenger side front while vehicle 2 sustained minor damage to the driver side rear.

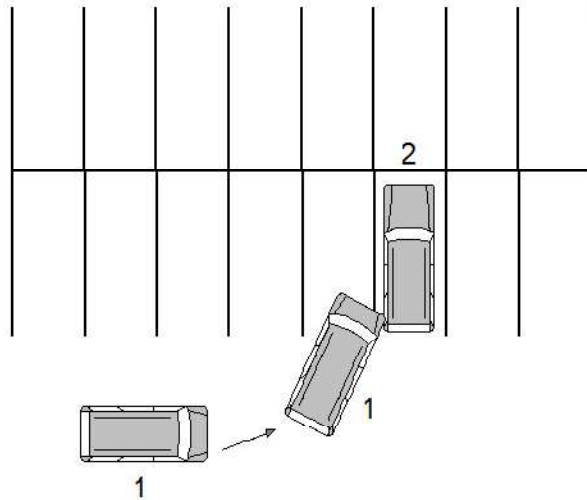
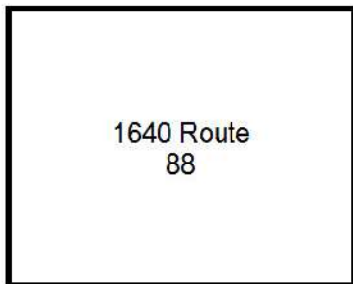
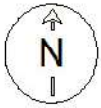
