145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction (rear-end) crash. Vehicle 1 was stopped directly behind vehicle 2 on Jack Martin Blvd. at the intersection of Jack Martin Blvd./Route 70. Both vehicles were in the center lane and both were stopped for a red traffic signal at said intersection awaiting to turn left onto Route 70 E.

The driver of vehicle 1 stated he observed the traffic signal for said intersection turn green at which time he began accelerating forward. The driver of vehicle 1 didn't realize vehicle 2 was still stopped directly in front of him and as a result of accelerating forward, the front end of vehicle 1 crashed into the rear end of vehicle 2. The driver of vehicle 2 stated she was stopped at the aforementioned intersection for a red traffic signal and that vehicle 1 had crashed into her vehicle moments after the traffic signal had turned green.

No injuries were reported and both vehicles sustained minor damage. The driver of vehicle 1 is at fault for the crash.

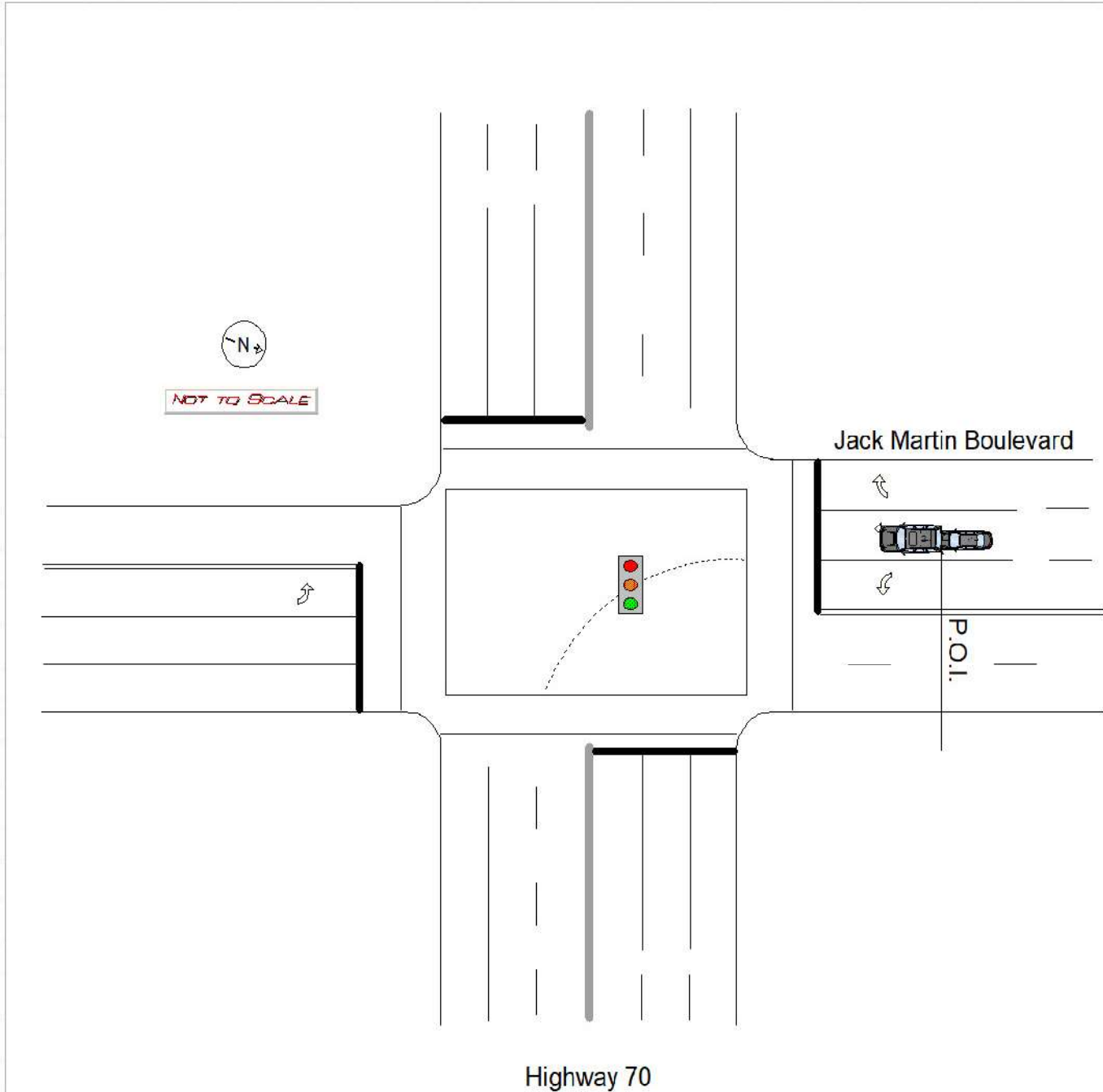
