145. Crash Description/Narrative

Vehicle #2 was traveling northbound on Jack Martin Blvd approaching the entrance to Ocean Medical Center, located at 425 Jack martin Blvd. Vehicle #1 was traveling directly behind Vehicle #2.

Driver #1 stated he was following Vehicle #2 when the driver stopped short attempting to turn into the hospital.

Driver #1 attempted to utilized the shoulder to go around Vehicle #2 but was unsuccessful and the left front of his vehicle struck the right rear bumper of Vehicle #2.

Driver #2 stated she was stopped as she was yielding to traffic in an attempt to make a left turn into the hospital entrance, when she was struck by Vehicle #1.

Based on both driver statements and my observations made on scene, I determined Vehicle #1 to be at fault for the crash.

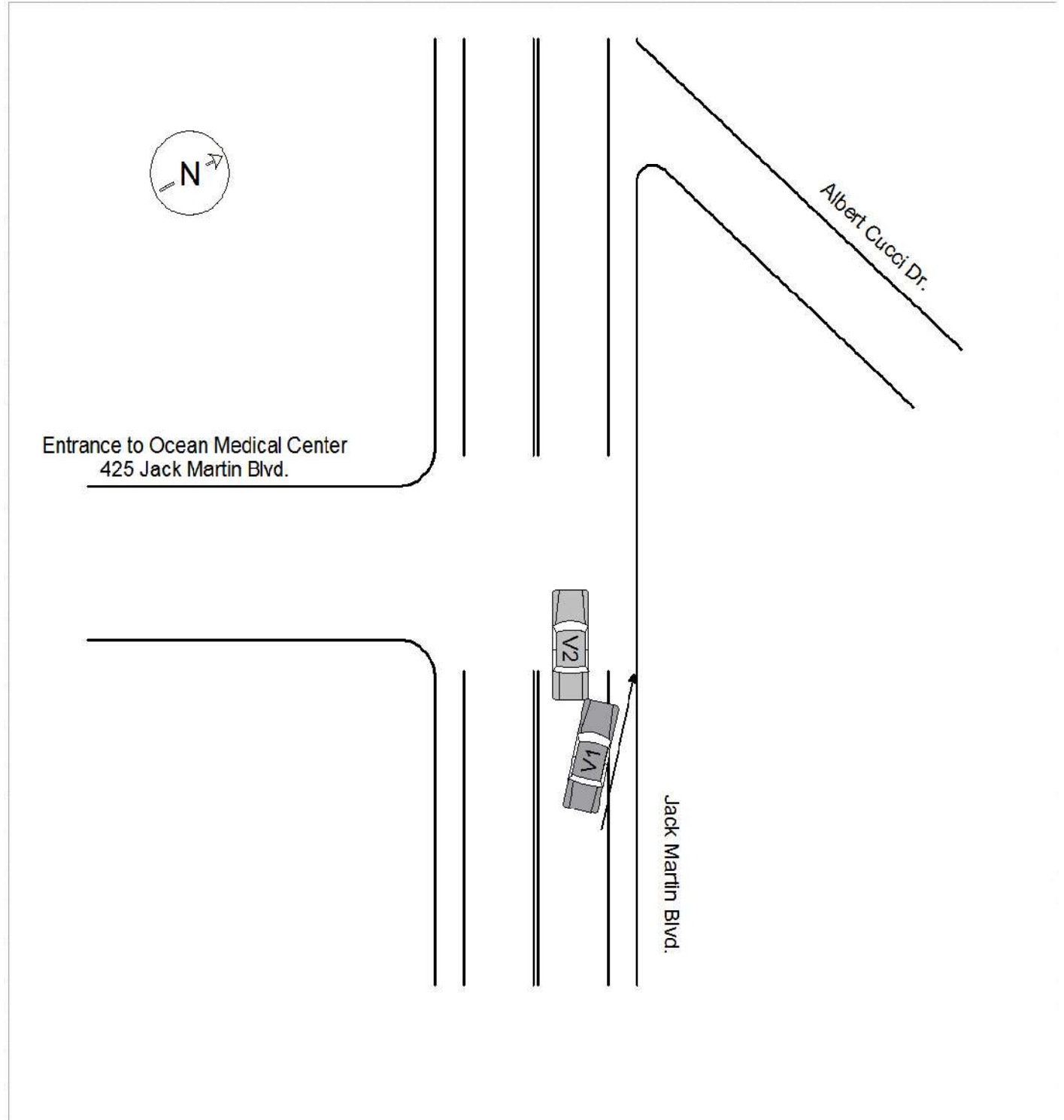
