145. Crash Description/Narrative

Vehicle #1 was traveling westbound Route 70 in the area of Rt 88. Vehicle #2 was directly in front vehicle #1.

While vehicle #2 was stopped for the red traffic signal vehicle #1 collided with it's rear end. Driver #2 stated she was stopped waiting for the light to change when vehicle #1 hit her in the rear. Driver #1 stated she looked down at her GPS on her cell phone and collided with the rear end of vehicle #2. Investigation revealed driver #1 was at fault for the accident.

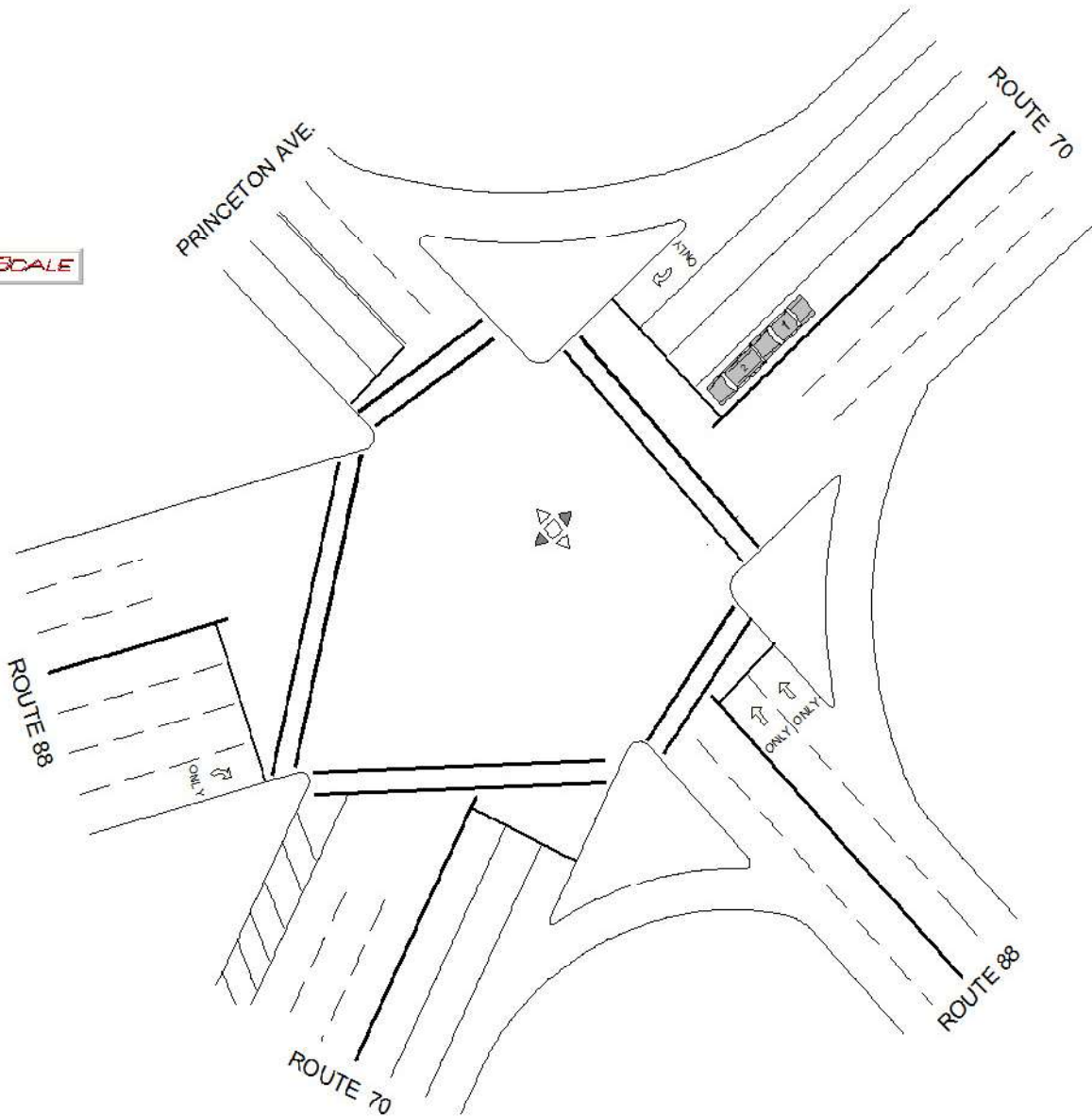
