145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 and #2 were traveling in the left lane on Rt. 70 (Westbound) approaching the Rt. 88 intersection. Vehicle #2 was stopped in traffic waiting for traffic to start after the green traffic signal. Vehicle #1 was to the rear of Vehicle #2, observed the green traffic signal and proceeded to move forward prior to Vehicle #2. Vehicle #1 struck the rear of Vehicle #2.

Driver of Vehicle #1 advised he was traveling on Rt. 70 to the rear of Vehicle #2 which was stopped in traffic. Driver of Vehicle #1 relayed he observed the green traffic signal and Vehicle #1 began to move forward. Driver of Vehicle #1 advised he failed to observe Vehicle #2 stop due to slow moving traffic because he was still looking at the green traffic signal. Driver of Vehicle #1 relayed he struck the rear of Vehicle #2.

Driver of Vehicle #2 advised he was stopped in traffic when Vehicle #1 struck the rear of his vehicle.

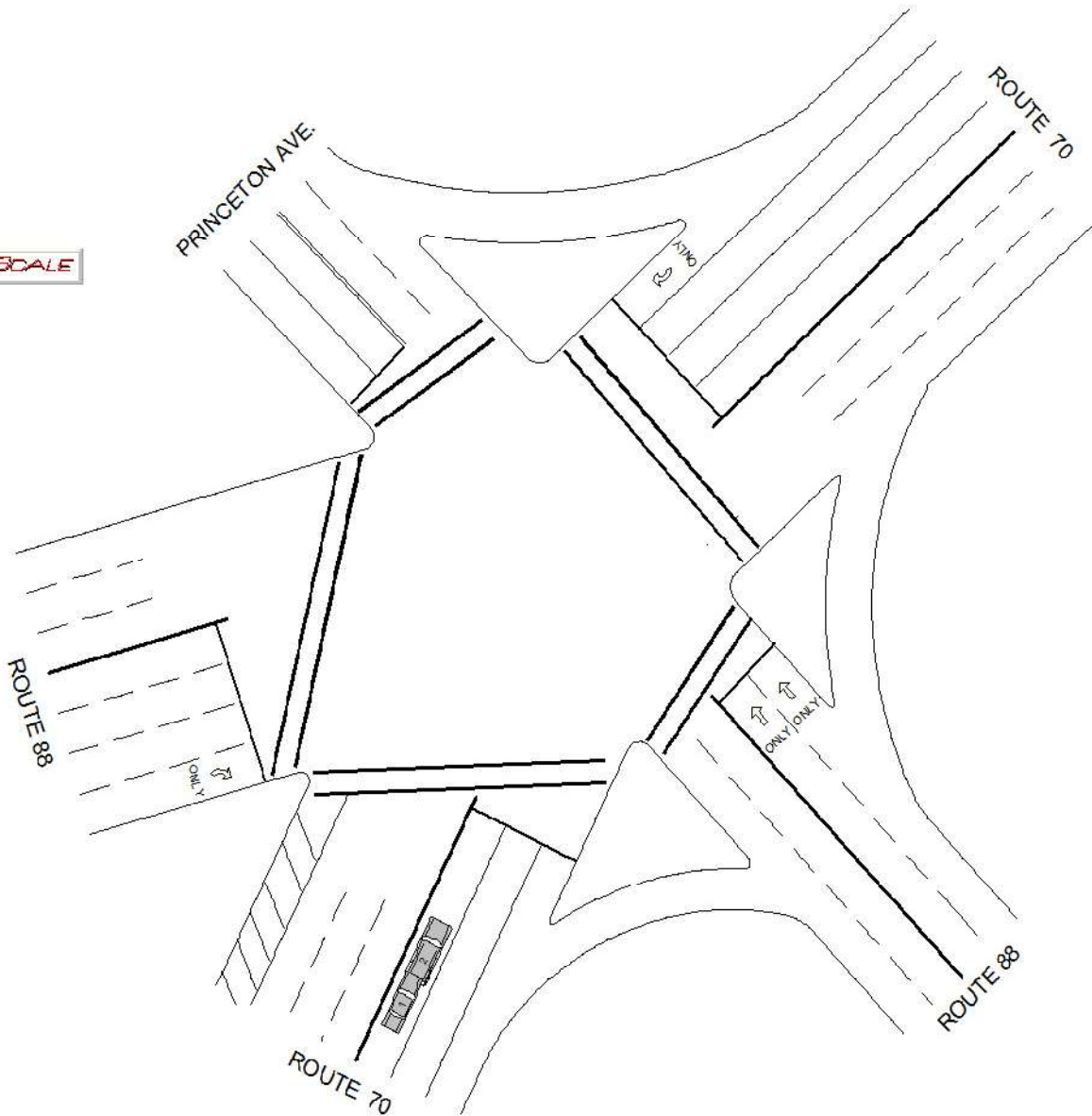
