145. Crash Description/Narrative

Vehicle#1 was stopped on the ramp leading from Route 88 East onto Route 70 West. Vehicle#2 was stopped in front of Vehicle#1 for traffic. Vehicle#1 pulled forward at which time Vehicle#1 struck Vehicle#2. Driver#1 stated that she was watching traffic and not Vehicle#2. Driver#1 stated that while watching traffic she pulled forward, not seeing Vehicle#2 was still stopped, causing Vehicle#1 to strike Vehicle#2. Driver#1 was determined to be at fault, drivers refused first aid and vehicles were moved prior to arrival.

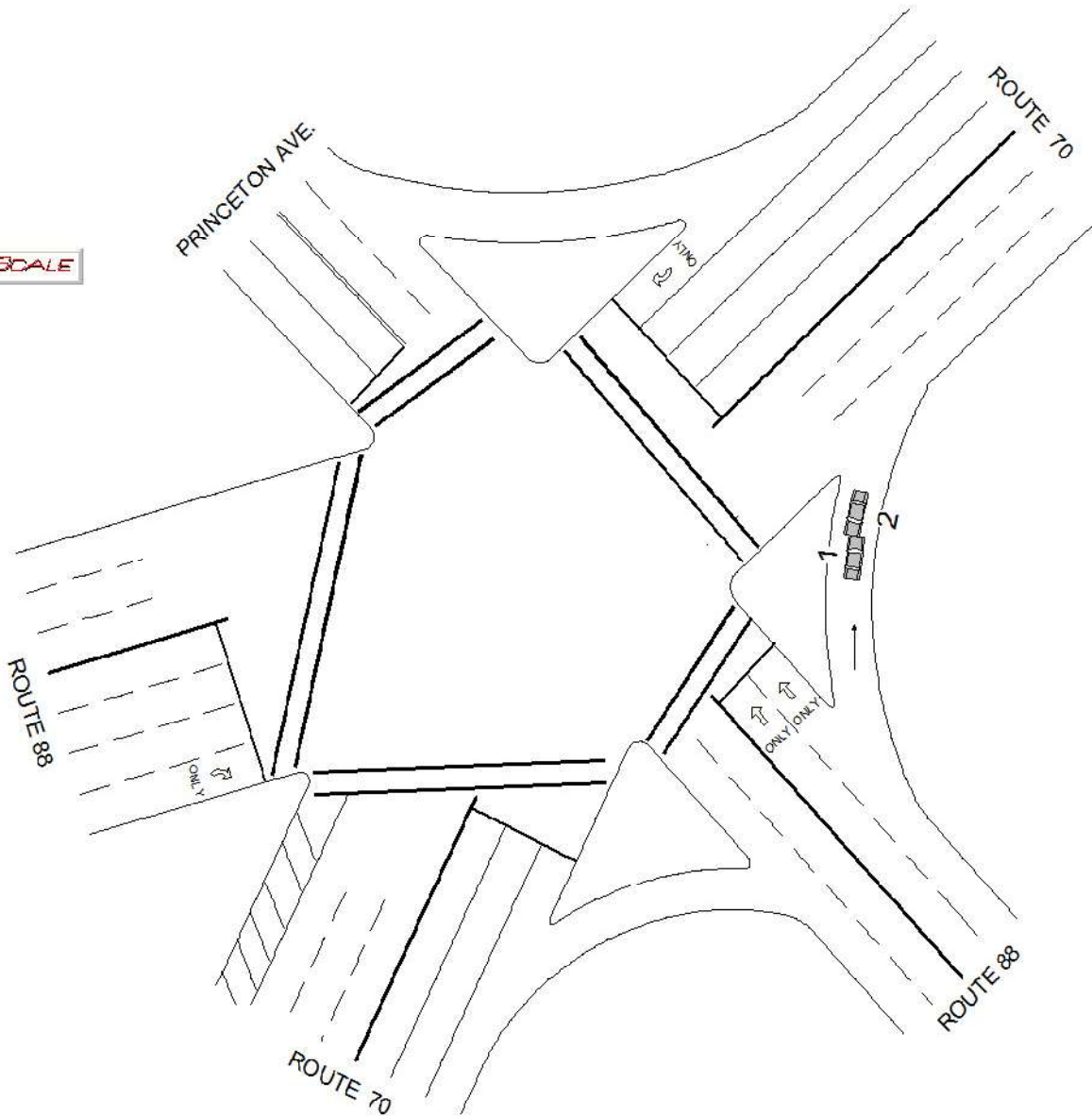
