145. Crash Description/Narrative

Vehicle #1 was traveling westbound on State Hwy 70, approaching State Hwy 88, in the left most lane. Vehicle #2 was traveling directly behind Vehicle #1. Vehicle #3 was traveling directly behind Vehicle #2.

Driver #1 stated she saw the traffic signal turn to yellow and then turn to red so she stopped her vehicle to avoid running through the red light. As she stopped her car, she was struck from behind by Vehicle #2 causing damage to Vehicle #1's rear bumper.

Driver #2 stated she was driving behind Vehicle #1 when it began to stop very quickly for the traffic signal turning yellow. Driver #2 was able to stop her vehicle safely until she was struck from behind by Vehicle #3, which pushed her vehicle into the rear of Vehicle #1. Vehicle #2 suffered damage to the front and rear of the vehicle.

Driver #3 stated he was following Vehicle #2 when he observed the traffic signal turn yellow and was able to see Vehicle #1 slow their vehicle abruptly. He attempted to stop his vehicle but was unsuccessful and the front of his vehicle struck the rear of Vehicle #2 causing it to collide with Vehicle #1.

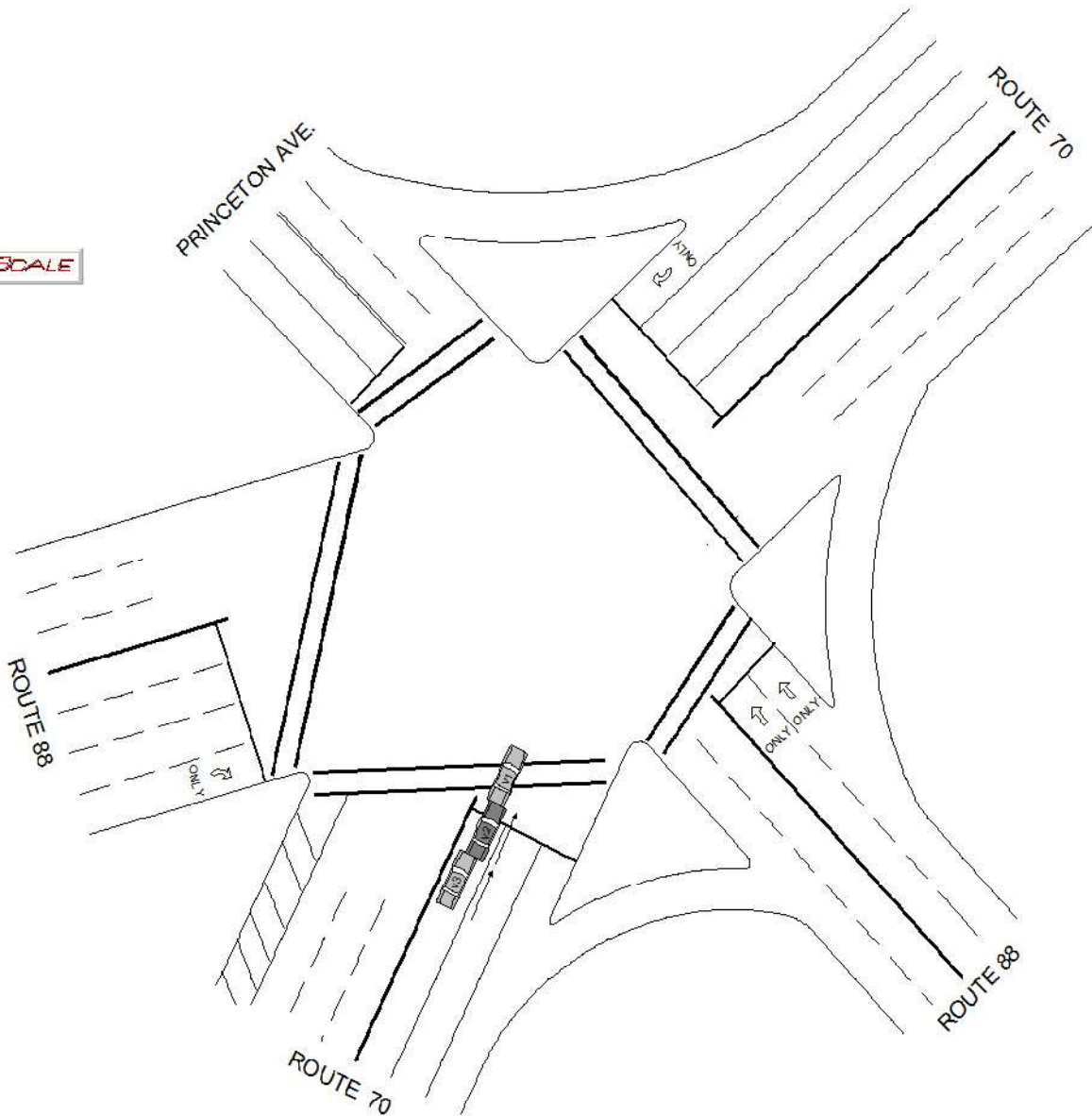
