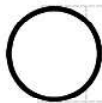

145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was attempting to make a left turn onto Route 88 from Laurel Square Shopping Center. Vehicle 2 was traveling West on Route 88 approaching the intersection with Laurel Square Shopping Center. Vehicle 1 attempted the turn in front of vehicle 2. Vehicle 2 attempted to avoid vehicle 1 but was unable to do so and the vehicles collided.

Driver 1 stated she was attempting to turn on to Route 88 and she did not see vehicle 2. Driver 1 stated the crash was her fault.

Driver 2 stated he observed vehicle 1 attempt to make a left in front of him. He attempted to veer to the left and avoid the crash but was unable to do so.

Based upon the above listed circumstances I find driver 1 to be at fault for the crash.

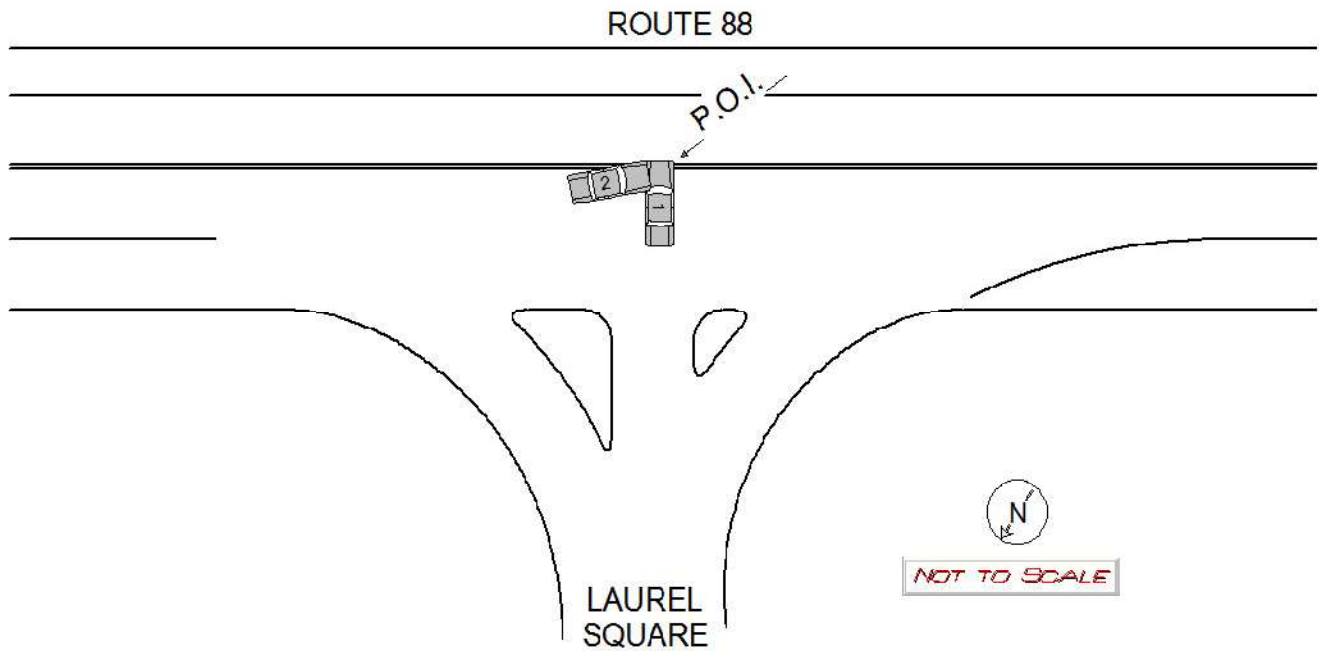
