145. Crash Description/Narrative

V1 was traveling eastbound on Rt. 88 approaching the intersection of Olden St. V2 was traveling southbound on Olden St. approaching the intersection of Rt. 88.

V2 was struck by V1 at a right angle in the intersection of Rt. 88 and Olden St.

D1 stated he was driving east on Rt. 88 in the right lane. He initially stated "When I looked up the truck was just there." He later stated he believed the truck had run the red light and that his own traffic signal was green.

D2 stated he was traveling southbound on Olden St. in the right lane. He stated there were three cars ahead of him, all of which had passed through the intersection while the light was green. He stated he had followed through the intersection and observed his light was still green. He stated he believed V1 had run through a red light.

A witness on location stated "The taxi is at fault. He ran the red light."

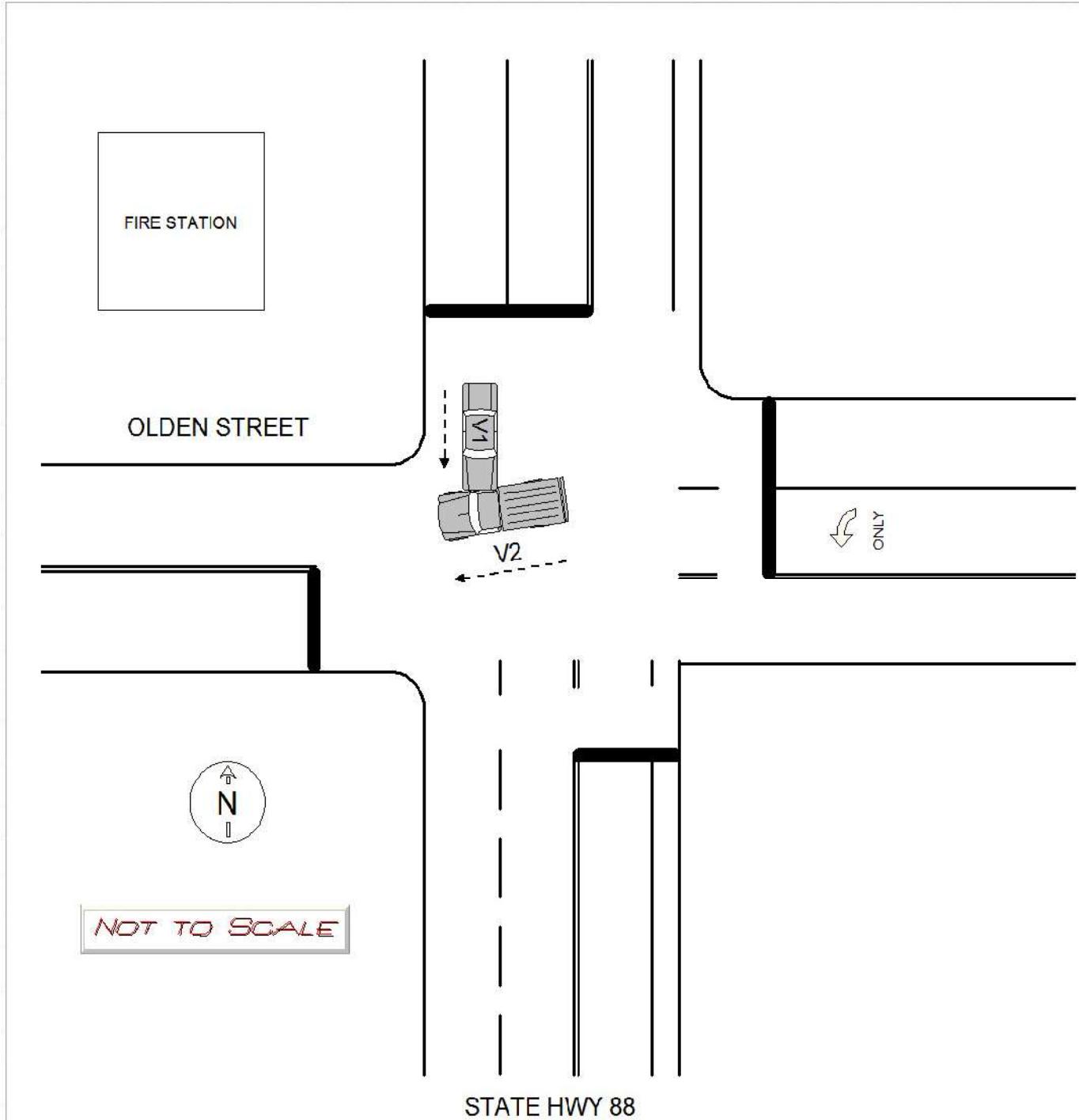
