145. Crash Description/Narrative

Vehicle 2 traveling westbound in the left lane of Route 88, approaching Post Road. Vehicle 1 traveling directly behind Vehicle 2.

Driver 1 stated he was traveling behind Vehicle 2, when it stopped abruptly for an unknown vehicle attempting a left turn onto Post Road. Driver 1 stated when he realized Vehicle 2 was stopping, he was unable to stop in time to avoid hitting the rear of Vehicle 2.

Driver 2 stated he had stopped for the turning vehicle when he was struck from behind by Vehicle 1.

Driver 1 was found to be at fault for following Vehicle 2 too closely.

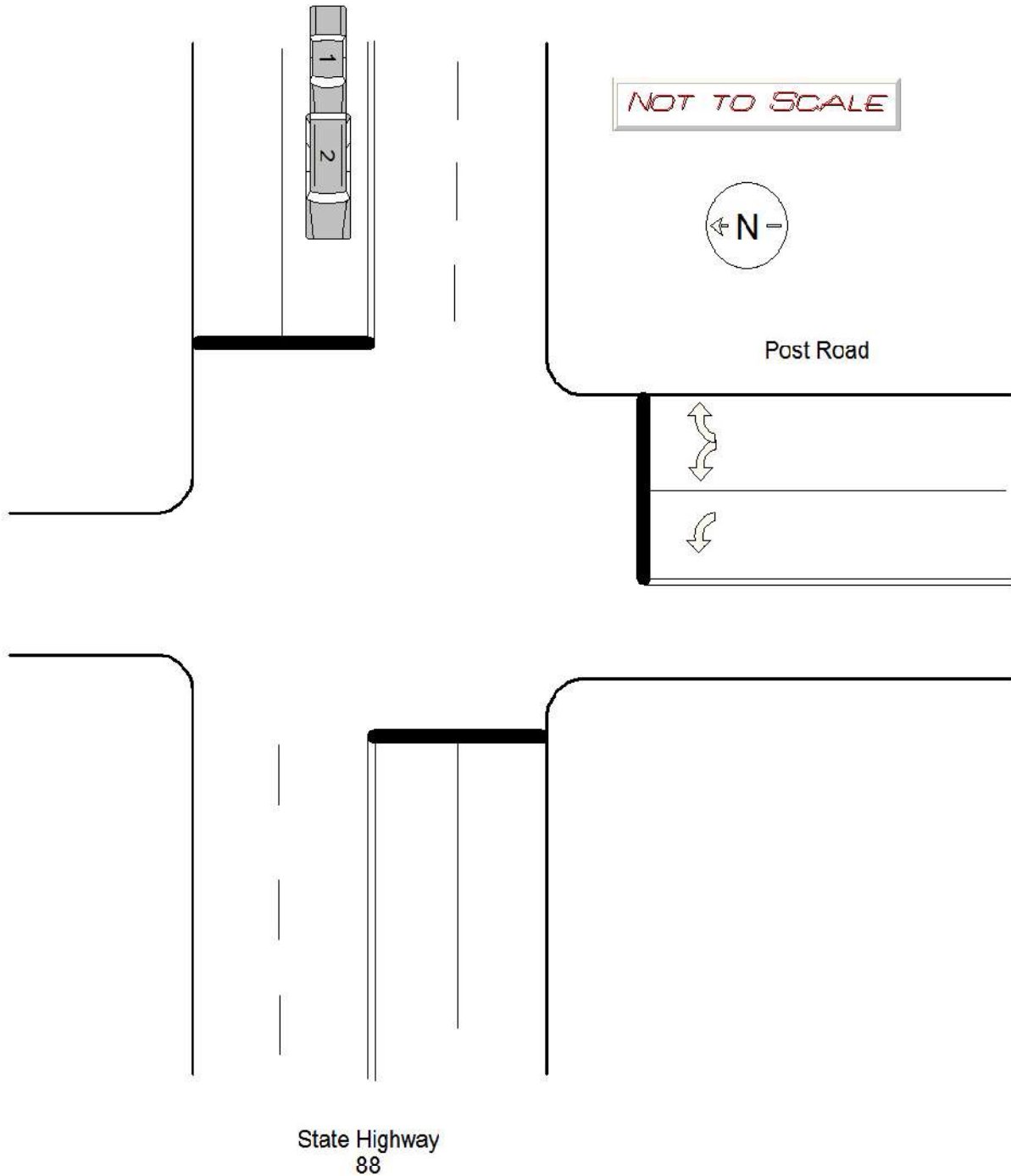
